RE: A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, ON BEHALF OF THE CITY OF OAKLAND, TO APPROPRIATE TO THE OFFICE OF THE CITY AUDITOR \$330,000 IN FISCAL YEAR 2008-2009 AND \$330,000 IN FISCAL YEAR 2009-2010 IN GENERAL PURPOSE FUNDS FOR THE PURPOSE OF FUNDING ADMINISTRATION OF THE CITY AUDITOR'S WHISTLEBLOWER PROGRAM

Dear Members of the Council:

On July 15, 2008 the City Council passed a Whistleblower Protection Ordinance, which protects City officers and employees against retaliation for whistleblowing and defines a process whereby complaints of fraud, waste, or abuse, and complaints of retaliation will be investigated by the Office of the City Auditor.

This resolution would authorize the City Administrator to appropriate to the Office of the City Auditor \$330,000 in fiscal year 2008-2009 and \$330,000 in fiscal year 2009-2010 in general purpose funds for the purpose of funding the administration of the City Auditor's Whistleblower Program.

The \$330,000 per year would fund the cost of investigations, the creation of a confidential whistleblower hotline, and an outreach campaign. We anticipate the activity in the program to be high in the first two years of operations based on similar municipal programs, therefore funds for investigations have been budgeted accordingly. If, however, activity is below our expectations, all unused funds will be returned to the General Fund.

At this time it is critical that we invest in the City Auditor's Whistleblower Program as a tool to regain the public's confidence in the integrity of City government. Moreover, given the City's current budget short fall, we must invest in a program that will combat fraud, waste and abuse, and bring increased efficiency to our government. We ask you to join with us in funding the Whistleblower Program and holding government accountable at the highest level.

Whereas, the City of Oakland has an interest in protecting the integrity of the City Auditor's Whistleblower Program; and

Whereas, the Office of the City Auditor presently lacks sufficient resources to administer the Whistleblower Program; and

Whereas, the Office of the City Auditor desires additional funding in the amount of \$330,000 in fiscal year 2008-2009 and \$330,000 in fiscal year 2009-2010 to establish a whistleblower hotline, investigate whistleblower tips and to process complaints of retaliation; now, therefore, be it
