#### **EXECUTIVE SUMMARY**

Adoption of the resolutions will authorize the City Administrator to enter into grant agreements during Fiscal Years 2017-2018 and 2018-2019 between the City and various organizations and non-profits that provide services, programs and resources to Oakland residents. The Human Services Department will administer grant agreements with the Unity Council, Family Bridges, Inc., Vietnamese American Community Center of the East Bay (VACCEB), and Vietnamese Community Development Inc. (VCDI) to provide services to seniors in the community. In addition, the Human Services Department will administer grant agreements with Service Opportunity for Seniors (SOS) to operate Oakland's Meals on Wheels program and Eden I&R Inc. to operate the 2-1-1 Telephone Line Service that provides Oakland residents a resource to information and referral services 24 hours a day.

The Oakland Parks and Recreation Department will administer grant agreements with East Bay Zoological Society, Chabot Space & Science Center, Oakland Children's Fairyland, Friends of Peralta Hacienda Historical Park, Oakland Asian Cultural Center and Oakland Parks And Recreation Foundation to provide community-based services and resources to Oakland residents.

#### **BACKGROUND/LEGISLATIVE HISTORY**

These resolutions accompany the Fiscal Year 2017-2019 Proposed Biennial Budget which includes allocations for each of the grant agreements. The City Council has historically funded these grant agreements as part of prior adopted budgets, including the last FY15-17 Adopted Biennial Budget. Executing the grant agreements for FY 2017-2019 will enable these non-profits to continue to operate programs and services benefiting Oakland residents without interruption.

## **ANALYSIS AND POLICY ALTERNATIVES**

This resolution authorizes the City Administrator to execute grant agreements with various non-profit agencies for Fiscal Years 2017-18 and 2018-19. The City currently has agreements in place with these non-profits which run in tandem with the City's budget cycle and expire on June 30, 2017. Funding in the amounts of \$1,336,123 for FY17-18 and \$1,239,615 for FY18-19 is allocated in the Mayor's Proposed FY2017-2019 Biennial Budget to support continuation of these community services which are focused on delivering recreational programs and services for Oakland residents, operations of Senior Centers serving the Asian community, Vietnamese community, and monolingual Spanish speaking seniors, delivery of meals to home bound seniors, and operation of the 2-1-1 call center, staffed with bilingual phone line resource specialists, that provides community information and referral services.

#### **COORDINATION**

The Human Services Department, the Parks and Recreation Department, and the Office of the City Attorney have been consulted regarding the preparation and review of this report and accompanying resolution.

#### **SUSTAINABLE OPPORTUNITIES**

**Economic**: Funding will support non-profit agencies operating senior centers, senior meals programs, and recreational programs. These agencies are all local and predominately Oakland-based and employ local staff, providing a positive economic impact.

Authorization of the grant agreement with Eden I & R will allow Oakland residents to continue access to 2-1-1 telephone services for information and referrals to vital social services, low to no-cost banking through the Bank on Oakland Initiative, free tax preparation through the Earned Income Tax Credit Campaign, and employment and housing which helps to promote economic and community development.

*Environmental*: There is no known environmental impact.

Social Equity: Human Services funding prioritizes services that reach seniors with the greatest need. Programs provide seniors with community engagement, health and hunger programs, and are congregating points for information and assistance for older adults residing in Oakland.

Funding allocated to non-profits that operate recreational programs supports the community by providing recreational services and programs for users of all ages.

Access to 2-1-1 telephone services will provide low-income Oakland residents with continued access to vital social services, employment and housing referral information, and financial empowerment opportunities to increase Oakland's overall social equity.

### ACTION REQUESTED OF THE CITY COUNCIL

Adopt two resolutions authorizing the City Administrator to enter into grant agreements during Fiscal Years 2017-18 and 2018-19 with East Bay Zoological Society in the amount of \$439,336. Chabot Space & Science Center in the amount of \$546,210, Oakland Children's Fairyland in the amount of \$273,000, Friends of Peralta Hacienda Historical Park in the amount of \$91,800, Oakland Asian Cultural Center in the amount of \$102,000, and Oakland Parks And Recreation Foundation in the amount of \$40,000 to support community programs and services benefiting residents of Oakland; and Family Bridges in the amount of \$159,360. Spanish Speaking Unity Council of Alameda County, Inc. in the amount of \$350,592, Vietnamese American Community Center Of The East Bay in the amount of \$36,720, and Vietnamese Community Development Inc in the amount of \$36,720 to provide operational support to senior centers; and Service Opportunity For Seniors in the amount of \$300,000 for the meals on wheels program to provide meals to seniors; and Eden I&R Inc., in the amount of \$200,000 for the provision of 2-1-1 telephone line services for information and referral services.
