RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF JANNY CASTILLO AND ADHI NAGRAJ AND THE REAPPOINTMENT OF MOSES MAYNE JR. AS MEMBERS OF THE OAKLAND HOUSING AUTHORITY BOARD OF COMMISSIONERS

WHEREAS, the City Council adopted Resolution No. 6341 C.M.S. pursuant to the California Health and Safety Code section 34270, which authorizes the City of Oakland to declare the need for a housing authority by adopting such a resolution; and

WHEREAS, California Health and Safety Code section 34270 authorizes the Mayor, subject to confirmation of a majority of the members of the Council, to appoint five commissioners; and

WHEREAS, California Health and Safety Code sections 34270 and 34272(d) provide (1) that the Mayor shall appoint, subject to the confirmation of a majority of the members of the Council, two additional commissioners who are tenants of the authority, one of whom shall be over 62 years of age if the authority has tenants of such age, and (2) that if a tenant commissioner ceases to be a tenant of the authority he/she shall be disqualified and another tenant shall be appointed to fill the unexpired term; and

WHEREAS, pursuant to California Health and Safety Code section 34272 the tenant commissioners' terms shall be two years; all other commissioners' terms shall be four years; and all vacancies shall be filled for the unexpired term; now therefore, be it

RESOLVED, that the City Council hereby confirms the Mayor's appointment of the following individuals to the terms set forth below:

Janny Castillo, appointment to complete the term beginning July 1, 2010 and ending June 30, 2012 filling the seat formerly held by Esther "Eve" Purvis.

Addendum to resume

I have been a client of the Oakland Housing Authority for approximately 17 years. OHA has provided the rental security and *through my case workers*, the emotional support I needed to build a solid foundation for me and my children. I have taken full advantage of the opportunities allotted through OHA, especially the Family Self-Sufficiency program and the OHA Section 8 Homeownership Program which taught me comprehensive information on how to save and purchase a home. The road to where I am today was not easy, when I received my section 8 certificate *many years ago*, my children and I were living in a transitional home for homeless families.

Over the last three years, the knowledge and the experience I received through OHA was extremely valuable when suffering from the mortgage crisis, I helped four of my family members, including my father navigate through the mountain of paperwork associated with short sales and loan modifications.

Through my work on the OHA's RAB board, my experience and conviction has fueled a passion to support our low income tenants and protect our existing affordable housing AND support positive endeavors to increase our nation's public housing stock.

Through my social justice work with BOSS, an Alameda County Homeless Service Provider, we collaborate closely with other organizations; East Bay Housing Organizations (EBHO), Just Cause-Causa Justa, St. Mary's Center, East Bay Community Law Center, Homeless Action Center, Urban Habitat, Western Regional Advocacy Project *just to name a few* to raise awareness on the need to protect and to build affordable housing for extremely low income individuals and families. We do not ignore the parallel need for transportation equity, access to affordable health care and viable income stability.

Even so, it is not enough to just provide shelter and services, folks need new ways to deal with trauma and challenges. To respond, I have developed a 24 week LYBL curriculum that I facilitate at the BOSS Village where consumers explore new ways to overcome emotional barriers to wellness and live life to the fullest no matter the consequences.

It is this passion and commitment that I bring to the table as an OHA Board Commissioner, if I am so honored and privileged.
