RESOLUTION:

- (1) EXTENDING THE CITY'S EXISTING VIOLENCE PREVENTION PROGRAM STRATEGIES AND FUNDING PRIORITIES FOR PROGRAMS FUNDED BY THE 2014 OAKLAND PUBLIC SAFETY AND SERVICES VIOLENCE PREVENTION ACT (SAFETY AND SERVICES ACT) FOR NINE MONTHS (I.E., TO MARCH 31, 2022); AND**
- (2) DIRECTING THE CITY ADMINISTRATOR TO ENGAGE IN FURTHER PUBLIC OUTREACH INCLUDING OUTREACH AND CONSIDERATION OF FUNDING TO GENDER-BASED VIOLENCE GROUPS, TO CONSIDER THE PUBLIC HEALTH FRAMEWORK, AND TO RETURN TO COUNCIL BY JUNE 30, 2021 WITH A REVISED PROPOSED SPENDING PLAN FOR COUNCIL'S CONSIDERATION**

WHEREAS, in November 2014, City of Oakland voters passed Measure Z, the Oakland Public Safety and Services Violence Prevention Act ("Safety and Services Act"), approving a series of taxes to support violence intervention objectives, including funding programs and services that provide support for high-risk youth and young adults to interrupt the cycle of violence and recidivism; and

WHEREAS, on December 11, 2018, the City Council passed Resolution No. 87477 C.M.S., which, among other things, approved through Fiscal Year 2020/2021 (*i.e.*, through June 30, 2021) the program strategies and funding amounts for programs funded by the Safety and Services Act ("Existing SSA Spending Plan"); and

WHEREAS, beginning in July 2020, the City's Department of Violence Prevention ("DVP") administers Safety and Services Act funds for violence intervention programs and services, whereby DVP prepares a spending plan to outline the strategies and services recommended for a new funding cycle; and

WHEREAS, the DVP developed spending plan recommendations concerning strategies to prioritize and the process for allocating funds in collaboration with community and public stakeholders that included community listening sessions and the Urban Strategies Council DVP planning process in 2018, review of local, national, and international best practices, and meetings and interviews with public and community stakeholders; and

WHEREAS, on December 8, 2020, the Life Enrichment Committee ("LEC") moved to forward to the City Council three alternative recommendations with respect to DVP's proposed spending plan, which LEC recommendations included an option (option No. 3) extending the Existing SSA Spending Plan by either six or nine months and directing the City Administrator to

return to Council by June 30, 2021 with a revised proposed spending plan; now, therefore, be it

RESOLVED: That the City Council (1) extends the Existing SSA Spending Plan by nine months (*i.e.*, through March 31, 2022) and (2) directs the City Administrator to engage in further public outreach including outreach and consideration of funding to gender-based violence groups, to consider the public health framework, and to return to Council by June 30, 2021 with a revised proposed spending plan for Council's consideration.


