**RESOLUTION AUTHORIZING A GRANT OF \$2,000 FROM COUNCILMEMBER NANCY J. NADEL'S PAY-GO FUNDS TO THE BAY AREA BLUES SOCIETY TO OFFSET EXPENSES INCURRED FOR THE CITY-SPONSORED 12<sup>TH</sup> ANNUAL HOME GROWN BLUES FESTIVAL**

**WHEREAS**, on July 17, 2007, the City Council revised the Pay-Go fund expenditure rules to authorize the use of Pay-Go funds for City, school and other public entity capitol improvements, furniture and equipment; and

**WHEREAS**, the City Council may approve use of Pay-Go funds for City-sponsored public interest community events operated by non-profits; and

**WHEREAS**, Councilmember Nancy J. Nadel wishes to grant a portion of her Pay-Go funds to the Bay Area Blues Society to be used to offset expenses they will incur in promoting and operating the 12<sup>th</sup> Annual Home Grown Blues Festival to be held in Oakland from July 9 through August 27, 2008; and

**WHEREAS**, the Annual Home Grown Blues Festival is a City-sponsored event that brings the Oakland community together for music and other entertainment, food, education and other civic activities beneficial to residents and businesses; and

**WHEREAS**, in conformance with City requirements, the Bay Area Blues Society will provide documentation for the use of the Councilmember's Pay-Go funds; now, therefore, be it

**RESOLVED**, that the City Council authorizes the grant of \$2,000 from Councilmember Nancy J. Nadel's Pay-Go funds to the Bay Area Blues Society for reimbursement expenses it will incur in promoting and operating the 12<sup>th</sup> Annual Home Grown Blues Festival to be held in Oakland from July 9 through August 27, 2008; and, be it

**FURTHER RESOLVED**, that the City Administrator is authorized to execute an appropriate grant agreement with the Bay Area Blues Society for the above purposes subject to approval as to form and legality by the City Attorney.
