ORDINANCE AMENDING THE SALARY SCHEDULE OF ORDINANCE NO. 12187 C. M.S. ("SALARY ORDINANCE") TO ADD THE FULL-TIME CLASSIFICATION OF ETHICS ANALYST III; TO ADD THE FULL-TIME CLASSIFICATION OF SIGN SHOP COORDINATOR; TO AMEND THE TITLE OF THE FULL-TIME CLASSIFICATION OF FIRE PREVENTION BUREAU INSPECTOR (CIVILIAN) TO FIRE INSPECTOR; AND TO AMEND THE SALARY OF THE PART-TIME CLASSIFICATION OF SENIOR AIDE TO ENSURE COMPLIANCE WITH THE CITY OF OAKLAND'S MINIMUM WAGE.

This ordinance authorizes changes to the City's Classification Plan as shown in the City's Salary Schedule to add new classifications and amend existing classification titles and salary rates. Various departments are requesting new classifications to align with operational and service delivery needs; this applies to the new Ethics Analyst III and Sign Shop Coordinator classifications. The job title of the Fire Inspector classification is being revised to modernize it by replacing a vague title with a more universal title that is readily recognized in the industry. Lastly, the pay rate for the Senior Aide, PT classification is being raised to align with the City of Oakland's new minimum wage rate that took effect January 1, 2020 per requirements in Measure FF and the Oakland Municipal Code Section 5.92.
