Dear President De La Fuente and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends settlement of the above-entitled matter arising from an incident on September 21, 2001, wherein it is alleged that Oakland Police Department officers falsely arrested and used excess force against Mr. Jackson.

Due to the risk of an adverse jury verdict under the circumstances, settlement is recommended in the amount of Two Hundred Fifty Thousand Dollars and No Cents (\$250,000.00), to be made payable to Javad T.M. Jackson and Pamela Y. Price, his attorney of record.
