### RESOLUTION NO. \_\_\_\_\_ C.M.S.

**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO A COOPERATIVE PURCHASING AGREEMENT WITH CARAHSOFT TECHNOLOGY CORP. FOR A TOTAL AMOUNT OF \$6,171,770, INCLUDING A TEN (10) PERCENT CONTINGENCY FOR OPTIONAL ADD-ONS AND UNANTICIPATED COSTS FOR A FIVE-YEAR TERM BEGINNING AUGUST 1, 2024 AND ENDING JULY 30, 2029 TO REPLACE THE OAKLAND POLICE DEPARTMENT'S RECORD MANAGEMENT SYSTEM WITH THE MARK43 MODERNIZED, CLOUD-HOSTED SOLUTION.**

**WHEREAS**, law enforcement records management system ("RMS") is a valuable source of relevant information essential to the investigative, arrest, and judicial processes; and

**WHEREAS**, the City had previously contracted with Motorola, Inc. to replace OPD's RMS system, which is outdated and no longer supported; and

**WHEREAS**, OPD has since determined that the Mark43 solution would better meet its needs now and in the future; due to being more streamlined, having an improved user interface, providing an easier way to implement the new NIBRS standard as it relates to report writing, and contains all the elements and components needed for a records management system to support public and officer safety; and

**WHEREAS**, the Mark43 solution is cloud-hosted and includes data and analytics tools, mobile app collections and seamless workflows, and can be fully integrated with the Motorola P1 Computer Aided Dispatch ("CAD") System and other critical public safety systems; and

**WHEREAS**, OMC Section 2.04.080 [Cooperate Agreement Purchasing] authorizes the use of agreements of "...other governmental jurisdictions or public agencies that were awarded pursuant to an appropriate competitive process"; and

**WHEREAS**, the cooperative purchase agreement is recommended to be executed with Carahsoft Technology Corp using NASPO Master Contract Number: AR247; Contract Number: 7-17-70-40-05; and

**WHEREAS**, the City Council already appropriated and allocated funding sufficient for Year 1 of this agreement in the Information Technology Fund (4600), CIP Not PW: Communication and Information Services Organization (94461), IBM2 911 PS Upgrade C468133 Project (1000439) and future years will be budgeted in the Information Technology Internal Service Fund 4600; and

**WHEREAS**, the City Council finds that any contracts related to the Mark43 RMS solution shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now therefore be it

**WHEREAS**, the City Council hereby finds that this agreement is for temporary services of a technical, scientific or professional nature; and

**WHEREAS**, the City Council further finds that this agreement shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore be it

**RESOLVED:** that the City Council finds and determines the forgoing recitals to be true and correct and hereby adopts and incorporates them into this Resolution; and be it

**FURTHER RESOLVED:** that the City Administrator or designee is authorized without returning to Council to negotiate and execute a cooperative purchase agreement with Carahsoft Technology Corp. to implement and support the Mark43 RMS solution and related products and services for OPD for a total amount of \$6,171,770; and be it

**FURTHER RESOLVED:** that for the reasons stated above and, in the report, accompanying this Resolution, the City Council hereby finds and determines that it is in the best interests of the City to waive the City's Local/Small Local Business Enterprise program requirements, and so waives these requirements for the information technology agreements; and be it

**FURTHER RESOLVED:** that this Resolution shall be in effect for a term beginning August 1, 2024, and ending July 30, 2029; and be it

**FURTHER RESOLVED:** that the agreement and any subsequent amendments or extensions shall be reviewed and approved by the Office of the City Attorney for form and legality prior to execution and placed on file in the Office of the City Clerk.
