Governing Code

Created by Resolution No. 74826 C.M.S., adopted March 2, 1999.

Fifteen Members (2-year terms, no more than two terms to be served consecutively)

8 appointed by Council, 1 appointed by Mayor to act as Chairperson, Chamber of Commerce provides list of 12 recommendations of which the Mayor appoints 3 additional members, the Chairperson of the Finance and Management Committee appoints 2 members, and the Chairperson of the Economic Development Committee appoints 1 member. All appointments subject to approval by the City Council. All members must be residents or tax-payers of the City of Oakland.

The Budget Advisory Committee provides fiscal management in an advisory capacity to the City Council.

This new committee has only recently been established, replacing the Business Budget Advisory Committee and the Citizen's Budget Advisory Committee.

Members of this Committee must submit a Conflict of Interest form (Form 700).
