RESOLUTION AUTHORIZING AMENDMENT NO. 2 TO THE AGREEMENT WITH KORVE ENGINEERING FOR ADDITIONAL ON-CALL DESIGN SERVICES FOR VARIOUS TRANSPORTATION PROJECTS FOR AN AMOUNT NOT-TO-EXCEED \$100,000, FOR A TOTAL CONTRACT AMOUNT NOT-TO-EXCEED \$300,000

WHEREAS, the Transportation Services Division of the Public Works Agency prioritizes the need for traffic signalization, bicycle facilities and pedestrian safety throughout the City; and

WHEREAS, based on funding, safety, accident rates, traffic volumes, pedestrian volumes and site conditions, a number of high-priority projects have been identified for this current fiscal year, and staff resources are limited; and

WHEREAS, having a pre-selected pool of specialty consultants, which can be called upon on an as-needed basis to provide consulting to staff for project design work, would expedite the design process and preserve the capital improvement, state and federal program funding; and

WHEREAS, Council Resolution No. 76690 C.M.S. authorizing an on-call design services agreement for various transportation projects (Agreement) with Korve Engineering, for an amount not-to-exceed \$75,000, was approved on September 18, 2001; and

WHEREAS, Council Resolution No. 77275 C.M.S. authorizing Amendment No. 1 to the Agreement, for an additional amount not-to-exceed \$125,000, was approved on July 9, 2002; and

WHEREAS, the City has a contractual need for additional design services on an as-needed basis; and

WHEREAS, the City Council finds that the services provided pursuant to the agreement authorized hereunder are of a professional, scientific, technical, and temporary in nature; and

WHEREAS, Council finds that this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

RESOLVED: That the City Manager, or his authorized representative, is hereby authorized to enter into Amendment No. 2 to the Agreement with **Korve Engineering** to provide additional design services for various transportation projects to the Transportation Services Division of the Public Works Agency for an additional amount not to exceed \$100,000, and for a total contract amount not to exceed \$300,000; and be it

FURTHER RESOLVED: That the City Manager, or his authorized representative, is hereby authorized to approve any subsequent amendments to or extensions of said agreement with the exception of those related to an increase in the total dollar amount of the agreement, provided that such amendments or extensions shall be filed with the Office of the City Clerk; and be it

FURTHER RESOLVED: That a copy of the agreement will be approved for form and legality by the Office of the City Attorney and will be on file in the Office of the City Clerk.
