RESOLUTION NO. 91136* C.M.S.

RESOLUTION 1) AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH CITY OF EMERYVILLE TO RECEIVE FOUR HUNDRED AND FIFTY-NINE THOUSAND EIGHT HUNDRED TWENTY-SEVEN DOLLARS AND NO CENTS (\$459,827) TO PROVIDE OAKLAND PUBLIC LIBRARY SERVICES TO EMERYVILLE RESIDENTS FOR FISCAL YEARS 2026-2027, 2027-2028, AND 2028-2029; AND 2) ACCEPTING AND APPROPRIATING SAID FUNDS

WHEREAS, Emeryville residents receive library services from Oakland Public Library; and

WHEREAS, the last agreement between the cities was for a three-year period and will expire on June 30, 2026; and

WHEREAS, by declining to enter into this agreement, there would be no revenue to City of Oakland, nor savings for reduced services because of "universal borrowing" requirements under California state law; and

WHEREAS, Emeryville will pay the City of Oakland \$145,861 for Fiscal Year (FY) 2026-27, \$153,154 for FY 2027-28, and \$160,812 for FY 2028-29, for a total amount of \$459,827; and

WHEREAS, the revenue received shall be deposited into the City of Oakland General Purpose Fund (1010) in project numbers to be assigned; and

WHEREAS, section 504 of the Oakland City Charter provides that the City Administrator may negotiate contracts for joint governmental actions, subject to Council approval; now, therefore, be it

RESOLVED: That the City Administrator is hereby authorized to enter into an agreement with the City of Emeryville whereby Emeryville will provide the City of Oakland \$145,861 for FY 2026-27, \$153,154 for FY 2027-28, and \$160,812 for FY 2028-29, for a total amount of \$459,827 in order for the City to provide Oakland Public Library services to Emeryville residents through FY 2026-27, 2027-28, and 2028-2029; and be it

FURTHER RESOLVED: That said funds from the City of Emeryville are hereby accepted and will be appropriated in the General Purpose Fund (1010) in project numbers to be assigned.


