RESOLUTION NO. 90158 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO NEGOTIATE AND EXECUTE A FIVE-YEAR AFFILIATION AGREEMENT WITH THE REGENTS OF UNIVERSITY OF CALIFORNIA, BERKELEY NUTRITION SCIENCES AND TOXICOLOGY DEPARTMENT TO CREATE INTERNSHIP ROTATION OPPORTUNITIES IN EARLY CHILDHOOD FOOD AND NUTRITION FOR CITY OF OAKLAND HEAD START.

WHEREAS, the City of Oakland ("City") operates an exemplary food and nutrition through the US Department of Agriculture's Child and Adult Care Food Program (CACFP) and nutrition care and programming throughout its Head Start and Early Head Start programs; and

WHEREAS, the Regents of University of California, Berkeley Nutrition Sciences & Toxicology Department provides coursework and dietetic internship coordination that prepares students to become Registered Dietitian Nutritionists in our community; and

WHEREAS, University of California, Berkeley Nutrition Sciences & Toxicology Department and the City hope to work together to provide opportunities for students interns to complete internship training hours at City Head Start school and food preparation sites with appropriate supervision and instruction; and

WHEREAS, student interns will not receive pay from the City and will not be City employees, and Head Start staff are coordinating with City Human Resources to ensure this program will fulfill City hiring requirements; and

WHEREAS, this partnership will provide future nutrition professionals with a deep understanding of Head Start, early childhood nutrition, and food service operations in the context of Federal, State, City and local regulations, in which their experience with City of Oakland Head Start will prepare to better our community's future RDNs to serve Oakland; now, therefore, be it

RESOLVED: That the City Council hereby authorizes the City Administrator to negotiate and execute a five-year Affiliation Agreement with Regents of University of California, Nutrition Sciences & Toxicology Department to create dietetic internship opportunities in early childhood food and nutrition for City of Oakland Head Start; and be it

FURTHER RESOLVED: That the City Administrator or designee is authorized to take all steps necessary to achieve the basic purposes of this resolution, including but not limited to amending the MOU as needed and submitting documentation.


