**Resolution Declaring the Results of the City of Oakland General Municipal Election held on Tuesday, November 6, 2012**

**WHEREAS**, pursuant to law and Section 1101 of the Charter of the City of Oakland, the City Council of the City of Oakland duly called for the Consolidation Of The City Of Oakland General Municipal Election With The Statewide General Election To Be Held In The City Of Oakland On Tuesday, November 6, 2012; and

**WHEREAS**, pursuant to Section 1105 of the Charter of the City of Oakland, ballots in the races for City Attorney, City Councilmember for Districts 1, 3, 5, 7, City Councilmember At-Large and School Board Director for Districts 1, 3, 5 and 7 were tabulated using Ranked Choice Voting; and

**WHEREAS**, the results stated below in the races for City Attorney, City Councilmember for Districts 1, 3, 5, 7, City Councilmember At-Large and School Board Director for Districts 1, 3, 5 and 7 reflect the final tally after the Ranked Choice Voting tabulation was conducted; and

**WHEREAS**, the Registrar of Voters for the County of Alameda has canvassed the returns of all votes cast in the City of Oakland pursuant to law; and

**WHEREAS**, the City Clerk does hereby certify the results for the General Municipal Election (Exhibit A); now, therefore, be it


