#### Summary of the Ballot Measure

The East Bay Regional Park District's Board of Directors has requested that the City of Oakland consider endorsement of the Park District's proposed park bond extension measure to be placed on the November 2008 ballot.

To summarize, the Park District's Board of Directors has acted to place a bond measure on the November 2008 ballot which would extend the 1988 voter approved Measure AA that made possible the addition of more than 34,000 acres of regional parkland and shoreline as well as provided \$60 million in funding for local parks and recreation projects. Oakland received \$10,244,208 in funding for city's various projects including the African Lion Exhibit and Flamingo Plaza, Brookfield Multi Purpose Senior Center, Joaquin Miller Park and Sequoia Lodge renovation, tennis courts resurfacing and various upgrades at the recreation centers and parks from Measure AA.

With the population in the East Bay growing faster than the number of parks and trails serving residents, the future of local parks and recreation projects and regional parks projects depend on funding from an extension of Measure AA.

The bond extension measure as developed by the Park District's Board of Directors would provide \$500 million in funding to permanently protect open space, ridgelands and shorelines for future generations. Twenty five percent (25%) or \$125 million of the bond revenue would go directly to local parks and recreation departments (and special park districts) on a per capita basis to meet local park needs. **Oakland would receive \$19,204,456 in funding from this measure to support our parks and recreation capital project needs**.

Seventy five percent (75%) of the funds would go to the East Bay Regional Park District to fund regional park acquisitions, openspace preservation, park development and habitat restoration.



The bond extension measure must be approved by two-thirds of voters in Alameda and Contra Costa Counties. Importantly, this extension will not increase the existing tax rate for property owners because the issuance of bonds will be structured to retain the property tax rate at or below the existing tax rate of \$10 per \$100,000 of assessed value for property owners.

#### **Positive Factors for Oakland**

The bond extension measure as developed by the Park District's Board of Directors would provide \$500 million in funding to permanently protect open space, ridgelands and shorelines for future generations. Twenty five percent (25%) or \$125 million of the bond revenue would go directly to local parks and recreation departments (and special park districts) on a per capita basis to meet local park needs. **Oakland would receive \$19,204,456 in funding from this measure to support our parks and recreation capital project needs.** 

In addition to the City's allocation the residents of the City of Oakland stand to gain even more because many of our trails, open space and parkland adjoins East Bay Regional Park land. Therefore, this measure places the citizens in a position to connect, improve and expand current trails, urban creeks and shorelines that will directly enhance the quality of life for Oakland residents.

A list of proposed park projects to be funded with Oakland's \$19.2 million share of this ballot measure is attached (Attachment A) for City Council review and approval. If City Council accepts this list of proposed park projects, City of Oakland voters will have a clear sense of how their vote will impact their own neighborhood parks.

### Looking to the Future Measure WW

- \$500 million
- Based on population per capita, 25% of revenue will fund local parks
- 75% of revenue will fund regional park acquisitions, open space preservation, park development, and habitat restoration
- No change in tax rate





### Looking to the Future Measure WW

- 25% of Measure WW revenue will fund city park projects
- \$125,000,000 distributed to cities on a per capita basis
- Oakland Parks will receive \$19.2 million
- Oakland Zoo will receive \$4 million
