## ORDINANCE ADOPTING THE 2002 EDITION OF CITY OF OAKLAND STANDARD DETAILS FOR PUBLIC WORKS CONSTRUCTION, AND REPEALING THE 1994 EDITION OF CITY'S STANDARD DETAILS FOR PUBLIC WORKS CONSTRUCTION, ORDINANCE NO. 12049 C.M.S. AND ALL AMENDMENTS THERETO

WHEREAS, the City Council periodically establishes the City of Oakland Standard Details for Public Works Construction applicable to Oakland's Public Works construction; and

WHEREAS, the City Council last established such Standard Details for Public Works Construction (1994 Edition) in 1998 by adoption of Ordinance No. 12049 C.M.S. adopted on April 7, 1998; and

WHEREAS, the City wishes to update its Standard Details for Public Works Construction to assist public and private designers in the design and construction of City facilities, and also to assure design uniformity governing City of Oakland public works construction;

NOW, THEREFORE, the Council of the City of Oakland does ordain as follows:

**SECTION I.** The Standard Details, a copy of which is on file in the Office of the City Clerk, entitled "City of Oakland Standard Details for Public Works Construction (2002 Edition)" are hereby adopted as the Standard Details for Public Works Construction in the City of Oakland.

**SECTION II.** The Director of Public Works is hereby authorized to amend or modify the Standard Details for Public works construction on an as-needed basis to reflect the improved materials and methods of construction and incorporate these technological innovations into the revised Standard Details.

**SECTION III.** The Director of Public Works is hereby authorized to periodically review and amend or modify the Standard Details for Public Works Construction to reflect the new requirements of ordinances and codes, which are mandated by the Municipal, State and Federal governments. Some of these requirements include California's Title 24 accessibility requirements and the Federal Americans with Disabilities Act (ADA) accessibility requirements.
