RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, ON BEHALF OF THE CITY OF OAKLAND, TO EXECUTE A GRANT AGREEMENT IN AN AMOUNT NOT TO EXCEED \$37,625.00 TO VALERIE HAMILTON TO FUND HEAD START FAMILY CHILD CARE HOME SERVICES FOR A ONE-YEAR PERIOD AND AUTHORIZING THE CITY ADMINISTRATOR TO EXTEND GRANT FUNDING FOR ONE ADDITIONAL YEAR IN AN ADDITIONAL AMOUNT NOT TO EXCEED \$37,625.00

WHEREAS, the Department of Human Services, Head Start Program has determined that family child care homes are a cost effective means of providing families with quality Head Start services and full-day, full-year child care; and

WHEREAS, the Head Start Program has received authorization from the U.S. Department of Health and Human Services to provide Head Start services for sixty-six children in family child care homes; and

WHEREAS, program applications were solicited and submitted from Oakland family child care home operators and several qualified applicants were interviewed and selected for the program; and

WHEREAS, the Department of Human Services has approved Oakland's selection of Valerie Hamilton to provide Head Start services in a family child care setting for 6 children; and

WHEREAS, this provider meets all of the requirements for Family Child Care Providers and was one of the top candidates who applied to the Family Child Care Provider program; and

WHEREAS, funds in the amount of thirty seven thousand six hundred twenty five dollars (\$37,625.00) are available to pay for these services in Department of Health & Human Services Fund (2128), Head Start Project (G264810), and Head Start Organization (78231); and

WHEREAS, the City Council finds that the performance of these grant services is professional, scientific or technical in nature and shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

RESOLVED: That the City Council hereby authorizes the City Administrator or her designee as an agent for the City to execute a grant agreement, contingent upon receipt of Head Start grant funding, with Valerie Hamilton, in an amount not to exceed thirty seven thousand six hundred twenty five dollars (\$37,625.00), and, be it further

RESOLVED: That the City Administrator or her designee, is hereby authorized to extend the grant agreement for one (1) additional year, under the same terms and conditions and contingent upon receipt of Head Start grant funding, for an additional amount not to exceed thirty seven thousand six hundred twenty five dollars (\$37,625.00).

RESOLVED: That the City Administrator or her designee, is hereby authorized to approve any subsequent amendments, modifications, or extensions of this grant agreement provided that such amendments or extensions shall be approved as to form and legality by the Office of the City Attorney and filed with the Office of the City Clerk.
