RESOLUTION AMENDING RESOLUTION NO. 90591 C.M.S. TO CONFIRM THE COUNCIL PRESIDENT'S UPDATED APPOINTMENTS OF THE COUNCILMEMBERS AND CHAIRPERSONS OF THE FINANCE AND MANAGEMENT, PUBLIC WORKS AND TRANSPORTATION, COMMUNITY AND **ECONOMIC** DEVELOPMENT, LIFE ENRICHMENT. PUBLIC SAFETY, RULES AND LEGISLATION, **EDUCATION** PARTNERSHIP, CITY/PORT AND LIAISON **COMMITTEES** 

WHEREAS, Rule 4 of the Council's Rules of Procedure, established by Resolution No. 90066 C.M.S., provides that the Council President shall appoint all committees and committee chairs subject to confirmation by Council resolution, and provided that a majority of the members of the Council may direct the appointment of a committee by the Council President; and

WHEREAS, on January 9, 2025, pursuant to Resolution No. 90591 C.M.S., the City Council confirmed the appointments to the Finance and Management, Public Works and Transportation, Community and Economic Development, Life Enrichment, Public Safety, Rules and Legislation, Education Partnership, ad City/Port Liaison Committees; and

WHEREAS, on April 15, 2025, there was a Special Municipal Election held in the City of Oakland for, among other things, filling the vacancies in the Office of the Mayor and the District 2 Council Office; and

WHEREAS, on May 20, 2025, the City Council declared the results of the April 15, 2025 Special Municipal Election, which includes declaring the candidates for the Office of Mayor and

the District 2 Council Office as elected to said offices to complete the remainder of their respective terms; and

WHEREAS, upon the declaration of said results and the swearing in of the candidate for the Office of Mayor, the Council President, who had assumed the office of the Mayor for the period of the vacancy, shall return to their councilmember seat; and

WHEREAS, the City Council wishes to confirm updated committee appointments that include the Council President and the District 2 Councilmember; now, therefore, be it
