David Kramer, who has been active in Organized Labor for more than 25 years, has served as **a** member of the Oakland Board of Port Commissioners since September, 1991.

Kramer serves **as** Executive Director *of* Social Services **Union/American** Federation *of* Nurses Local 535, headquartered in Oakland, with more than 21 thousand members throughout California, affiliated with the Service Employees International Union, AFL-CIO.

He has held various positions in SEIU Locals 535,616 and the International Union from 1971 to **1996** when he assumed his current position *of* Executive Director of Local 535.

He also serves on the Executive Boards of the Central Labor Council of Alameda County, and the Service Employees International Union, as well as the Western Conference and California State Council of SEIU.

He has been a member **of** the Executive Board of the Bay Area Seamens' Service, the Labor Studies Advisory Board of the San Francisco Community College, and is a Trustee of the Health Care Employees/Employers Dental and Medical Trust. He is also a former member **of** the International Brotherhood of Teamsters in Detroit and the United Steel Workers **of** America in Pittsburgh.

Born in Pittsburgh Pennsylvania in 1941. he received a bachelor's degree in Industrial Design from Carnegie Institute Of Technology (now Carnegie Mellon University) and a masters degree in Social Work from the University of Michigan.

Kramer has been a resident of Oakland for more than 25 years.
