**RESOLUTION:**

**1. ACCEPTING AND APPROPRIATING DIRECT LOCAL PROGRAM DISTRIBUTION MEASURE BB FUNDS IN THE AMOUNT OF \$3,197,068 FOR FISCAL YEAR (FY) 2025-2026 FROM THE ALAMEDA COUNTY TRANSPORTATION COMMISSION FOR OAKLAND PARATRANSIT FOR THE ELDERLY AND DISABLED PROGRAM TO PROVIDE ACCESS TO SPECIALIZED TRANSPORTATION SERVICES;**

**2. AWARDING REIMBURSEMENT AGREEMENTS FOR PARATRANSIT SERVICES FOR FY 2025-2026 IN THE AMOUNTS OF \$850,000 (FIVE RIVERS TRANSIT SOLUTIONS, INC.), \$600,000 (QUALITY TRANSIT, LLC), \$350,000 (BAY AREA CHARTERS, INC.), \$25,000 (ONE ACCESS, MEDICAL TRANSPORTATION) AND \$75,000 (GOGO TECHNOLOGIES, INC.);**

**3. AWARDING GRANT AGREEMENTS IN THE AMOUNT OF \$50,000 (CITY OF EMERYVILLE) FOR PARATRANSIT SERVICES AND \$300,000 (SERVICE OPPORTUNITY FOR SENIORS) FOR MEAL DELIVERY SERVICES TO ISOLATED AND DEPENDENT ELDERLY AND DISABLED PERSONS; AND**

**4. AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE ANY ADDITIONAL DIRECT LOCAL DISTRIBUTION FUNDS THAT MAY BECOME AVAILABLE FOR FY 2025-2026 AND AMEND THE AFOREMENTIONED AGREEMENTS TO INCREASE THE AMOUNTS WITHIN THE LIMITS OF THE FUNDING**

**WHEREAS,** voters in Alameda County passed Measure B in November 1986, reauthorized Measure B in November 2000, and passed Measure BB in November 2014, thereby providing sales tax revenues for paratransit services; and

**WHEREAS,** Measure BB funds will be required by the City of Oakland for Fiscal Year (FY) 2025-2026 for the purpose of providing subsidized transportation to the frail-elderly and persons with disabilities who have limited access or are deemed unable to use public transit; and

**WHEREAS**, the City of Oakland is an eligible recipient for Alameda County Measure BB funds from the Alameda County Transportation Commission; and

**WHEREAS**, the partial funding for the grant agreements are contingent upon the availability and carryforward of prior Measure BB funds in the Measure BB Paratransit Fund (2220), Oakland Paratransit for Elderly and Disabled Organization (75621), various prior year Measure BB Projects and, Empowering Seniors & People With Disability Program (YS14); and

**WHEREAS**, the City of Oakland's FY 2025-2026 Proposed Budget for FY 2025-2026 includes Measure BB fund appropriation in Measure BB Paratransit Fund (2220), Oakland Paratransit for Elderly and Disabled Organization (75621), OPED FY 2025-2026 Measure BB Projects (10067657 and 1007658), Empowering Seniors & People With Disability Program (YS14); and

**WHEREAS**, the City's RFP/RFQ process is not applicable because the City enters into reimbursement agreements, on a non-exclusive basis, with taxi or related companies with a minimum fleet of five or more vehicles; accessible van, accessible shuttle or charter bus companies with adequate fleet capacity and design; and supplemental service and/or coordination transportation entities qualified, capable and permitted to provide specialized transportation services for seniors, frail-elderly and adult persons with disabilities in Oakland; and the City provides reimbursement on behalf of the community member to the selected companies; and

**WHEREAS**, the City desires to maintain this service without interruption;

**WHEREAS**, the City lacks the fleet, the equipment and the support structure to operate this service with City employees and has never provided or operated such a service; and

**WHEREAS**, all of the companies and organizations for which agreement authorization is being requested meet the City's requirements for providing or coordinating paratransit services; and

**WHEREAS**, the City wishes to award to and enter into reimbursement agreements with the following paratransit providers in the following amounts for FY 2025-2026, as specified below:

**FURTHER RESOLVED:** That the City Administrator is hereby authorized to negotiate and execute reimbursement agreements and grant agreements with the above-named entities in the amounts set forth above and to modify, extend or amend the aforementioned agreements to increase the amounts awarded for FY 2025-2026, subject to the availability of funding; and be it

**FURTHER RESOLVED:** That estimated fees to be collected in the amount of \$115,000 by Oakland Paratransit for the Elderly and Disabled (OPED) in conjunction with van voucher sales, taxi scrip sales and other service fares for OPED transportation services included in the Proposed Policy Budget FY 2025-2026, in accordance with the terms of the existing agreements are designated for the exclusive use of OPED to Measure BB Paratransit Fund (2220), Oakland Paratransit for the Elderly and Disabled Organization (75621), OPED FY 2025-2026 Measure BB Projects (1007657 and 1007658), Empowering Seniors & People With Disability Program (YS14);  
and be it

**FURTHER RESOLVED:** That should additional Measure BB funds become available during FY 2025-2026 for paratransit services, the City Administrator is authorized to accept and appropriate those funds to Measure BB Paratransit Fund (2220), Oakland Paratransit for Elderly and Disabled Organization (75621), OPED FY 2025-2026 Measure BB Projects (1007657 and 1007658), Empowering Seniors & People With Disability Program (YS14); and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to take any other action necessary and consistent with this Resolution and its basic purposes.
