RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR HIS DESIGNEE TO:

- 1) ENTER INTO A COUNTY OF SAN MATEO AGREEMENT UNDER WHICH THE CITY OF OAKLAND WILL PROVIDE ITS POLICE PERSONNEL DURING THE TERM JULY 1, 2011 THROUGH JUNE 30, 2012 IN EXCHANGE FOR SUPPLEMENTAL GRANT FUNDING IN CONNECTION WITH THE NORTHERN CALIFORNIA REGIONAL INTELLIGENCE CENTER (NCRIC) OPERATION URBAN AREAS SECURITY INITIATIVE (UASI), WHICH IS A FEDERAL, STATE AND LOCAL PUBLIC SAFETY EFFORT THAT INVOLVES THE INTAKE, FUSION, SYNTHESIS. **APPROPRIATE** ANALYSIS, AND DISSEMINATION OF CRIMINAL AND HOMELAND SECURITY INTELLIGENCE IN THE GREATER SAN FRANCISCO BAY AREA AND THE NORTHERN COASTAL COUNTIES OF CALIFORNIA; AND
- 2) ACCEPT AND APPROPRIATE FEDERAL FISCAL YEAR 2010 UASI GRANT ALLOCATIONS THROUGH THE SAN MATEO COUNTY JULY 1, 2011 JUNE 30, 2012 AGREEMENT OF TWO HUNDRED TWENTY THOUSAND NINE HUNDRED TWENTY TWO DOLLARS (\$220,922) FOR REIMBURSEMENT OF SALARIES AND BENEFITS PAID TO OAKLAND POLICE DEPARTMENT PERSONNEL THAT ARE ASSIGNED AS LIAISON OFFICER PER THE COUNTY OF SAN MATEO NCRIC AGREEMENT

WHEREAS, the U.S. Department of Homeland Security's Homeland Security Grant Program allocates grant funds to address unique planning, equipment, training and exercise needs of high-threat, high-density Urban Areas to assist in building enhanced and sustainable capacities to prevent, protect against, respond to and recover from acts of terrorism; and

WHEREAS, the City of Oakland Fire Department's Office of Emergency Services was previously allocated Federal Fiscal Year (Calendar Year) 2010 Urban Areas Security Initiative grant funds to supplement emergency preparedness and response activities within the City of Oakland, and in alignment with a Governance Memorandum of Understanding with the City of San Jose, Santa Clara County, Alameda County, and the City and County of San Francisco; and

WHEREAS, the Fire Department's Office of Emergency Services is receiving supplemental Urban Areas Security Initiative grant funding for police services in connection with the Northern California Regional Intelligence Center (NCRIC) Operation Urban Areas Security Initiative, which is a federal, state and local public safety effort that involves the intake, analysis, fusion, synthesis, and appropriate dissemination of criminal and homeland security intelligence in the greater San Francisco Bay Area and the northern coastal counties of California that will be administered by the County of San Mateo; and

WHEREAS, the supplemental Federal Fiscal Year 2010 UASI grant funding can be used for police salaries and benefits in City's fiscal year 2011-2012; and

WHEREAS, San Mateo County will enter into an agreement with the City of Oakland under which the City of Oakland's police personnel will provide services in connection with the operation of the Northern California Regional Intelligence Center (NCRIC) from July 1, 2011 through June 30, 2012 in order to receive the supplemental funding; and

WHEREAS, the supplemental grant funding will be used to reimburse the Oakland Police Department for a Police Officer position for salary and benefits from July 1, 2011 through June 30, 2012; and

WHEREAS, the supplemental grant funding will not cover the central service overhead cost for the position; and

WHEREAS, the central service overhead costs will be waived; now, therefore, be it

RESOLVED: That the City Council hereby authorizes the City Administrator or his designee to enter into an agreement with the County of San Mateo for City of Oakland's police personnel to provide NCRIC services from July 1, 2011 through June 30, 2012 in connection with the Northern California Regional Intelligence Center (NCRIC) Operation Urban Areas Security Initiative and Federal Fiscal Year supplemental 2010 UASI grant allocation to Oakland in exchange for reimbursement of two hundred twenty thousand nine hundred twenty two dollars (\$220,922) for police salary and benefits; and be it

FURTHER RESOLVED: That the City Council hereby authorizes the City Administrator or his designee to accept and appropriate supplemental fiscal year Federal Fiscal Year 2010 UASI grant allocations of up to two hundred twenty thousand nine hundred twenty two dollars (\$220,922) for reimbursement of police salaries and benefits; and be it

FURTHER RESOLVED: That revenues and appropriations will be allocated to the Federal Grant Fund (2123), Office of Emergency Services Division Org. (20711), Office of Emergency Services Division Program (PS21), Fiscal Year 2010 UASI Project Account to be set up; and be it

FURTHER RESOLVED: That the City Council hereby authorizes that the City Administrator, as agent of the City, or his designee, to complete all required negotiations, certifications, assurances, and documentation required to accept, modify, extend and/or amend the grant award; and be it

FURTHER RESOLVED: That any contracts approved hereunder shall be reviewed for form and legality by the Office of the City Attorney.
