**Re:** Supplemental Information to An Annual Status Report from the Chief of Police on the Activities of the Alcoholic Beverage Action Team (ABAT) Unit and Its Deemed Approved Program and Tobacco Retail Licensing Initiative

---

### SUMMARY

As requested by the Public Safety Committee on March 8, 2011, staff has prepared this supplemental report on activities associated with the Alcohol Beverage Action Team (ABAT) unit of the Oakland Police Department.

#### *ABAT Action Institutions*

ABAT conducted a total of 22 decoy enforcement operations for the year 2010, at 286 alcoholic and tobacco retail establishments in Oakland. This number is in addition to routine inspections and site visits. Merchants are considered *successful* during the enforcement operation when a refusal to sell alcohol or tobacco products to the decoy is the end result. Conversely, merchants are considered *unsuccessful* when a decoy purchases alcohol or tobacco products. ABAT has concluded that education and feedback provided to the merchants has resulted in a 90% refusal rate for alcohol and 77 % refusal rate for tobacco. *Attachment A* provides a list of merchants that ABAT has had enforcement action against in 2010 as well as the disposition of each action through criminal and civil administrative action(s).

#### *When Does ABAT Take Action Against A Problematic Location*

In the event that a merchant who is monitored by ABAT is associated with repeated criminal and/or nuisance activity that impinges upon the public safety and welfare of the community ABAT will conduct an investigation to determine the following:

- The nature of the problem (i.e., drug dealing, loitering, sales of alcohol to minors, etc.)
- Individuals involved (i.e., clerks from the store or area residents)
- The frequency of the problem (i.e., chronic vs. acute)

At the conclusion of the investigation ABAT may refer the case as appropriate to any of the following agencies:

- Department of Alcoholic Beverage Control;
- Board of Equalization;
- City of Oakland Attorney's Office-Special Prosecution Team;
- City of Oakland Administrator's Office.

*Who Has Authority To Shut Down A Problematic Store*

ABAT does not have the authority to "shut down" a problematic location or revoke authorization for the merchant to sell alcohol or tobacco products. Licensing agencies may only revoke a merchant's authorization to sell an alcohol/tobacco product after a civil hearing. The Alameda County Health Department and the Oakland Fire Department are the only agencies with the authority to immediately force a store to close, otherwise closures require civil action.

The following actions were taken against merchants in 2010:

- Fandango Latino, located at 9829 San Leandro Street was immediately closed as a result of ALCO Health and OFD Violafions.
- High Street Billiards, located at 1452 High Street was forced to close after civil action.
- La Raza (Bancroft Market & Deli), located at 5001 Bancroft Avenue lost the ability to sell alcoholic beverages.
- Mullens Liquor, located at 4001 Broadway lost the ability to sell alcoholic beverages.
- One Thousand Points Laundromat, located at 10016 MacArthur Boulevard lost the ability to sell tobacco products.
- Illegal "After Hours Clubs" located at 1201 46<sup>th</sup> Avenue, 5795-7 Foothill Boulevard, and Players Club located at 8933 San Leandro Boulevard were closed and evicted by the property owners after ABAT enforcement action.

ABAT has identified 20 problematic alcohol/and or tobacco retailers in the City. Negative activity associated with each store location may include some or all of the following nuisance activities: Narcotics dealing inside/outside of the store, sales of alcohol/tobacco to minors, loitering, public intoxication, graffiti, side show activity, cabaret violations, violent crimes occurring on property, and receiving/selling stolen merchandise. The priority location list below is based on the following selection criteria: community complaints, calls for service, arrest reports, police reports, PST/ABAT Officer observations, and other intelligence sources.

ABAT uses additional resources to bring problem locations back to productive use, and to prevent new locations from becoming a potential problem. By working with business owners, other outside agencies, and community members, ABAT can assist in keeping businesses free from nuisance activities; these strategies include:

- Conducting *Crime Prevention Through Environmental Design* (CPTED) inspections.
- Requesting operating conditions/restrictions on new or existing locations in the event the ABC license changes ownership.
- Meeting with licensee/business owners and/or property owners to discuss/prevent nuisance activity.
- Providing annual training (free of charge) to all alcohol and tobacco retailers in the Deemed Approved/TRL program.
- Attending community meetings at the request of NCPCs to provide information on nuisance locations, and assist the community with identified priorities.
- Conducting annual inspections on each Deemed Approved/TRL location to check for compliance with federal, state, and local laws.
- Consulting with Department of Alcoholic Beverage Control, City Administrator's Office, Special Prosecution Team, and other agencies as appropriate when a nuisance exists at an establishment to coordinate enforcement efforts.


*Description of ABAT Cases Referred To City Of Oakland Attorney's Office For The Year 2010*

ABAT provides the Special Prosecution Team (SPT) with a referred case; at which time an evaluation of the evidence is then conducted by SPT personnel to determine if there is sufficient evidence to proceed with a civil, criminal, or administrative hearing. If there is sufficient evidence, SPT attorney(s) will have the case charged and proceed with the applicable court procedures. If there is insufficient evidence, the SPT will inform the assigned ABAT officer and work with the officer to fully develop the case. **Attachment B** provides a detailed list of nine cases that were referred to the City Attorney's Office by ABAT in 2010.


