RE: A Supplemental Report Regarding Funding Recommendations For Cultural Services Organizational Assistance Grants, And A Request To Adopt One Of

Three Alternative Resolutions:

1. A Resolution Awarding 15 Grants For Organizational Assistance In A Total Amount Not To Exceed \$516,381 As Originally Recommended; OR

- 2. A Resolution Awarding 26 Grants For Organizational Assistance In A Total Amount Not To Exceed \$516,381; OR
- 3. A Resolution Awarding 18 Grants For Organizational Assistance In A Total Amount Not To Exceed \$516,381

#### **SUMMARY**

This report provides three options to City Council for the distribution of funds to Oakland-based arts organizations within the City of Oakland Cultural Funding Program's Organizational Assistance grants category, in response to direction from the Life Enrichment Committee to staff on November 16, 2010.

#### FISCAL IMPACT

FY 2010-11 funds for the Cultural Funding Program Organizational Assistance grants category are budgeted as follows: \$363,909 in Non-Departmental (CCAD - Cultural Programs – 90523), General Purpose Fund (1010); and an amount (projected from future revenues) of \$152,472 from the Transient Occupancy Tax (fund 2419) surcharge set aside within the Cultural Funding Unit (88742) and the Cultural Funding Program-Transit Occupancy Tax project (P391850.) For any grants funded through the Cultural Funding Program (CFP) that will contribute to the costs of works of permanent public art, the grantee/project sponsors shall maintain, at their expense, the public art improvements. Neither the City, the Community & Economic Development Agency, nor the Cultural Arts & Marketing Department will be responsible for ongoing maintenance of the public art improvements.

#### **BACKGROUND**

26 eligible applications for Organizational Assistance Program funding were received from Oakland-based organizations in the FY 2010-11 grant cycle. These applications were forwarded to the Organizational Assistance Program review panel, a body convened exclusively for the review of this grants category.

Organizational Assistance grants support general operating expenses and strategic development. The criteria for review and scoring of Organizational Assistance grant applications are:

- 1. Evidence of the organization's programs advancing one or more of the CFP's goals and objectives (up to 20 possible points);
- 2. Artistic and programmatic quality (up to 30 possible points);
- 3. Finance and management (up to 30 possible points);
- 4. Marketing and outreach (up to 20 possible points); and
- 5. Application preparation (up to four bonus points).

The Organizational Assistance grants review panel recommended 15 applications for funding. This year, review panels met prior to Council's adoption of the FY 2010-11 budget, so the panels provided allocation guidelines but not recommended dollar amounts (as they have in the past) to the Funding Advisory Committee, which allocated funds once the City budget was finalized. Going forward, staff will adjust the grants program calendar so that panels begin meeting immediately after Council adopts its annual budget.

As a key element of program policy, the original allocation recommendation includes the award of reduced amounts to larger organizations. The Organizational Assistance panel forwarded its rankings with a recommendation to tier the awards so that larger groups, and their accompanying larger requests, received a smaller percentage, creating more opportunity for small- to mid-size organizations. The recommended breakdown of reductions was as follows:

- Requests of \$45,000 and up would be recommended for 70% of the request.
- Requests of below \$45,000 and above \$10,000 would be recommended for 75% of the request.
- Requests of \$10,000 and below would be recommended for 100% of the request.

On July 14, 2010, the Funding Advisory Committee reviewed all funding recommendations from the panels and allocated funds available based on panel scoring. The Committee then forwarded the recommendations to the Cultural Affairs Commission for approval. On July 26, 2010, the Cultural Affairs Commission unanimously approved all of the CFP grant recommendations.

Please note that the Organizational Assistance Program is a two-year program. The funding cycle will commence in FY 2010-11 and will conclude in FY 2011-12. Grantee award amounts will be identical in both years.

#### **KEY ISSUES & IMPACTS**

At the November 16, 2010 meeting of the Life Enrichment Committee, CEDA's Cultural Arts & Marketing Department staff presented the recommendations of the Organizational Assistance grants review panel and the Funding Advisory Committee to award 15 grants to Oakland-based organizations. The Life Enrichment Committee directed staff to return with alternate-funding scenarios that would include the award of a grant to the Oakland Interfaith Gospel Choir and to other eligible applicants within the Organizational Assistance category that scored within one point of the panel's recommended funding cutoff; staff was invited to present other options for consideration as well.

The options identified by staff are as follows:

- 1. Award 15 Cultural Funding grants for Organizational Assistance in a total amount not to exceed \$516,381. This is the original recommendation of the Organizational Assistance grants review panel, the Funding Advisory Committee and the Cultural Affairs Commission (see Attachment A). It is the recommendation of staff that Council approve this recommendation, which is supported by an extensive public review process fairly administered and in keeping with past practice. Staff will provide further outreach to the Oakland Interfaith Gospel Choir and other organizations to strengthen and increase the competitiveness of their applications in future years.
- 2. Award 26 grants for Organizational Assistance in a total amount not to exceed \$516,381. Through this option, all eligible applications within the grant category would be funded (see Attachment B). A portion of their grant request would be awarded to all organizations considered eligible within the category and scoring above the minimum 70 points. In this scenario, the integrity and results of the public participatory grants review process would remain intact. This funding category is for general operating support, and all organizations will benefit from some level of funding within this challenging economic climate. However, the 15 organizations originally recommended for funding will take significant reductions to their recommended grant amounts: an average of an additional 40.5% reduction, in addition to the up to 30% reduction already imposed by the Funding Advisory Committee due to limited funds available.
- 3. Award 18 grants for Organizational Assistance in a total amount not to exceed \$516,381. This option is directly responsive to the Life Enrichment Committee's request (see Attachment C). The recommended funding cutoff would be adjusted to include the Oakland Interfaith Gospel Choir, the Friends of Peralta Hacienda Historical Park, and the Oakland Ballet, as all three organizations scored within one point of the cutoff. These three organizations would have been the next three applicants recommended for funding had

adequate funds been available. However, this option would require a reduction in all recommended grants within this category: an average of a 14% reduction, in addition to the up to 30% reduction already imposed by the panel due to limited funds available.

#### SUSTAINABLE OPPORTUNITIES

Economic: Community oriented arts activities bolster the cultural arts identity of

Oakland, fortifying the city as a destination, and creating positive publicity

resulting in varying levels of economic return.

Environmental: There are no environmental opportunities or benefits resulting from any

action outlined in this report.

Social Equity: The organizations and activities being recommended for funding add to

existing economic and educational opportunities, thereby increasing the

quality of life for all Oaklanders and visitors to the city.

#### DISABILITY AND SENIOR CITIZEN ACCESS

The only impacts and benefits to the disabled and senior citizen communities resulting from actions outlined in this report would be from the proposed activities for the applicants being recommended for funding. There are, among the applicants recommended for funding, a number of organizations that specifically serve disabled and senior communities.

#### RECOMMENDATION & RATIONALE

Cultural Arts & Marketing Department staff and the Funding Advisory Committee recommend no changes to the original recommendation presented for the award of grants through the CFP's Organizational Assistance Program. Staff recommends that City Council accept this report and approve the original recommendation (Option 1 herein) to make 15 awards for the first year of the CFP Organizational Assistance grant category's two-year funding cycle, in a total amount not to exceed \$516,381 from existing General Purpose Fund and Transient Occupancy Tax surcharge funding. However, at the request of the Life Enrichment Committee, several other thoughtful options are presented here.

To the extent that the City Council continues to prioritize this use of General Fund resources, staff recommends the funding awards contained in the resolutions which accompany the original staff report.

#### ALTERNATIVE RECOMMENDATION

If Council does not support any of the options presented, Council may elect to identify a separate source of funding in order to award one additional grant, to Oakland Interfaith Gospel Choir. This course of action would preserve the integrity of the CFP public review process and the standing recommendations, and preserve the budgeted Organizational Assistance grant funding

Had additional funds been available and the application of Oakland Interfaith Gospel Choir recommended for funding based on the panel scoring, the recommended grant amount would have been \$24,000, which is 75% of OIGC's original request and is commensurate with the scoring of other organizations within this category by the panel.

#### ACTION REQUESTED OF THE CITY COUNCIL

Staff requests that the City Council accept this report and approve the original recommendation of 15 awards for the first year of the Cultural Funding Program Organizational Assistance category's two-year funding cycle, in a total amount not to exceed \$516,381 from existing General Purpose Fund and Transient Occupancy Tax surcharge funding.
