The Mayor's Office respectfully requests that City Council consider the reappointment of four current members to the Oakland Housing Authority Board, as well as the appointment of one

new member to fill an existing vacancy.

The Oakland Housing Authority Board continues to play a vital role in addressing our city's affordable housing crisis through strategic oversight of public housing programs, Section 8 voucher administration, and housing development initiatives. Maintaining experienced board members ensures continuity in ongoing housing projects and consistency in policy implementation, while bringing in a new voice will enhance the board's diversity of perspectives

and strengthen community representation in housing decisions.

Proposed Actions:

• Reappoint four qualified board members for new terms

• Appoint one new member to fill vacant board seat

• Maintain institutional knowledge while introducing fresh housing advocacy perspectives

Ensure quorum for commission meetings

Next Steps: The Mayor's Office will present both the reappointment and new appointment recommendations at the next Council meeting. We greatly appreciate any support you can provide in expediting this process and welcome the Council's prompt consideration of these appointments and reappointments.
