RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE THE FISCAL YEAR (FY) 2023-2025 SURRENDERED AND ABANDONED VESSEL EXCHANGE (SAVE) GRANT PROGRAM IN THE AMOUNT OF ONE HUNDRED SIXTY-SIX THOUSAND TWO HUNDRED FIFTY DOLLARS (\$166,250) TO FUND THE ABATEMENT, REMOVAL, STORAGE AND DISPOSAL OF ABANDONED VESSELS, AND AUTHORIZE THE CITY'S GENERAL PURPOSE FUND TO CONTRIBUTE SIXTEEN THOUSAND SIX HUNDRED TWENTY-FIVE DOLLARS (\$16,625) TO COVER THE ASSOCIATED CENTRAL SERVICES OVERHEAD (CSO) COSTS

WHEREAS, the State of California Department of Parks and Recreation awarded funds in the amount of one hundred sixty-six thousand two hundred fifty dollars (\$166,250) to the Oakland Police Department for the FY 2023-2025 Surrendered and Abandoned Vessel Exchange Grant Program; and

WHEREAS, the Surrendered and Abandoned Vessel Exchange Grant Program period is from October 1, 2023 through September 30, 2025; and

WHEREAS, the funds must be used for the abatement, removal, storage and disposal of abandoned vessels, wrecked or dismantled vessels, parts, or any other partially submerged objects that pose a substantial hazard to navigation from navigable waterways or adjacent public property, or private property with the landowner's consent; now, therefore, be it

RESOLVED: That the City Council authorizes the City Administrator or designee to accept and appropriate the Surrendered and Abandoned Vessel Exchange Program allocation in the amount of one hundred sixty-six thousand two hundred fifty dollars (\$166,250); and be it

FURTHER RESOLVED: That revenues and appropriations will be allocated to the State of California Fund (2159); Support Operations Division Org (107510); Program, Project and Accounts to be determined; and be it

FURTHER RESOLVED: That all contracts issued hereunder shall be reviewed and approved by the City Attorney for form and legality and copies shall be placed on file in the City Clerk's Office; and be it

FURTHER RESOLVED: That the City Administrator, or designee, is hereby authorized to complete all required negotiations, certifications, assurances, and documentation required to accept, modify, extend and/or amend the agreement.
