

Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends adoption of a resolution authorizing compromise and settlement of the plaintiff's claims in the above-entitled lawsuit for the Twenty Thousand Dollars (\$20,000.00) to be made payable to plaintiff Michael Pickering and Brian McCarthy, Esq., his attorney.

This action arises out of a trip and fall on the sidewalk in front of the Kaiser hospital at 280 W. MacArthur Boulevard on March 24, 2006. The settlement is recommended to avoid the risk of an adverse trial result and potentially greater economic exposure for the City.
