RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE GRANT FUNDS IN AN AMOUNT OF \$963,000.00 FROM THE UNITED STATES DEPARTMENT OF JUSTICE TO FULLY REIMBURSE THE CITY'S COST TO REPLACE AGING PUBLIC SAFETY NETWORK INFRASTRUCTURE AND ENHANCE PUBLIC SAFETY NETWORK CYBERSECURITY PROTECTIONS FOR THE PERIOD OF OCTOBER 31, 2024, THROUGH PROJECT COMPLETION.

WHEREAS, Grant funds in the amount of \$963,000.00 have been awarded to the City of Oakland to reimburse all project costs associated with the submitted project "Cyber Security Enhancements to Public Safety Systems"; and

WHEREAS, The grant funds are awarded by the United States Department of Justice (DOJ) Fiscal Year 2024 COPS Technology and Equipment Program Invitational Solicitation; and

WHEREAS, The City's project will be led by the Information Technology Department in close coordination with the Oakland Police Department and include the replacement of critical infrastructure components within the City's public safety network that have reached end-of-life and include the review and implementation of additional cybersecurity measures to protect City's public safety network; and

WHEREAS, DOJ has awarded funds to the City under this program because DOJ has determined that the City's project will help improve the flow and security of information among law enforcement agencies, local government service providers and the communities they serve; now therefore be it

**RESOLVED:** That the City Council does hereby authorize the City Administrator, or designee, to accept and appropriate the DOJ grants funds in an amount of \$963,000.00, to fully reimburse the City's project costs associated with this grant award; and be it

**FURTHER RESOLVED**: That the DOJ grant funds shall be recorded in the Information Technology Department Grant fund (2112), Network Security and Maintenance Organization (46471), Project (TBD), Technology Management Program (IP62); and be it

**FURTHER RESOLVED**: That the City Administrator, or designee, is authorized to conduct all negotiations, applications, agreements, amendments, and related actions which may be necessary to the completion of the aforementioned grant and to execute in the name of the City of Oakland, all grant documents, including without limitation, applications, agreements, amendments, requests for payment, and any extensions, necessary to secure and maintain the DOJ grant, and be it

**FURTHER RESOLVED**: That the agreement and any subsequent amendments authorized hereunder shall be reviewed and approved by the City Attorney for form and legality and shall be placed on file in the Office of the City Clerk.
