**RESOLUTION:**

- 1) **ACCEPTING, APPROPRIATING, AND AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO AN AGREEMENT FOR RECEIPT OF GRANT FUNDS IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TEN THOUSAND DOLLARS (\$110,000) FROM THE ALAMEDA COUNTY SOCIAL SERVICES AGENCY FOR CONTINUED OPERATION OF THE INFORMATION AND ASSISTANCE (I&A) PROGRAM FOR OAKLAND SENIORS FOR FISCAL YEAR (FY) 2025-26; AND**
- 2) **AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE ANY ADDITIONAL FUNDS FROM ALAMEDA COUNTY SOCIAL SERVICES AGENCY FOR THE I&A PROGRAM WITHIN FY 2025-26; AND**
- 3) **AUTHORIZING A CONTRIBUTION FROM THE GENERAL PURPOSE FUND FOR \$43,819 IN REQUIRED MATCHING FUNDS AND AN AMOUNT EQUIVALENT TO THE CENTRAL SERVICES OVERHEAD CHARGES IN AN ESTIMATED AMOUNT OF \$30,506 FOR FY 2025-26**

**WHEREAS**, in Oakland, 30 percent of elderly persons who are fifty years of age and older live below the poverty level; and

**WHEREAS**, local governments have played an important role in assisting older adults in maintaining their standard of living; and

**WHEREAS**, the Human Services Department's (HSD) Aging and Adult Services Information and Assistance (I&A) Program links older adults who need assistance to the appropriate service(s) within the communities and, to the maximum extent practicable, establishes adequate follow-up procedures; and

**WHEREAS**, the City desires to continue to support the I&A Program by accepting this program baseline funding from the Alameda County Social Services Agency, Area Agency on

Aging in an amount not to exceed One Hundred Ten Thousand Dollars (\$110,000) for the continued operation of the I&A Program for Oakland seniors for the Fiscal Year (FY) 2025-2026; and

**WHEREAS,** the funds will be appropriated in Human Services Department Social Services Grant Fund (2160), HSD Outreach Program Organization (75251), Outreach Program Project (1007660) and Empowering Senior and People with Disabilities Program (YS14); and

**WHEREAS,** the HSD is requesting, as it has in prior years, a contribution from the General Purpose Fund in matching funds \$43,819 and an amount equivalent to Central Services Overhead charges in an estimated amount of \$30,506 for FY 2025-26; now, therefore, be it

**RESOLVED:** That the City Council hereby accepts, appropriates, and authorizes the City Administrator to enter into an agreement for receipt of a grant in an amount not to exceed One Hundred Ten Thousand Dollars (\$110,000) for FY 2025-26 from the Alameda County Social Services Agency for continued operation of the Information and Assistance (I&A) program for Oakland seniors; and be it

**FURTHER RESOLVED:** That the City Council hereby approves the City's match requirement in an amount not to exceed Forty-Three Thousand Eight Hundred Nineteen Dollars (\$43,819) from the General Purpose Fund and all Central Services Overhead charges, in an estimated amount of Thirty-Thousand Five Hundred and Six Dollars (\$30,506) for FY 2025-26, associated with this grant will be offset through a contribution of the General Purpose Fund; and be it

**FURTHER RESOLVED:** That if additional grant funding becomes available from the Alameda County Social Services Agency, for the same purpose for FY 2025-26, the City Administrator or designee is hereby authorized to accept and appropriate these funds for the I&A Program and amend the grant agreement with Alameda County Social Services Agency as may be necessary.
