SUBJECT: RESOLUTION AUTHORIZING THE CITY MANAGER TO APPLY FOR, ACCEPT AND APPROPRIATE A GRANT IN THE AMOUNT OF \$1,352,467 FROM THE STATE DEPARTMENT OF AGING FOR THE MULTIPURPOSE SENIOR SERVICES PROGRAM (MSSP) FOR FISCAL YEAR 2003-2004 AND AUTHORIZING THE CITY MANAGER TO CONTRACT WITH NINE AGENCIES FOR AN ESTIMATED AMOUNT OF \$297,543 ANNUALLY TO PROVIDE IN-HOME SERVICES TO THE CLIENTS OF MSSP

PURPOSE AND SCOPE

In accordance with the Measure H Charter Amendment, which was passed by the voters at the General election of November 5, 1996, we have made an impartial financial analysis of the accompanying Agenda Report and Draft Resolution. The purpose of our analysis was to ascertain (1) whether the proposed amounts were reasonable, and (2) their impact on the general fund. In making our analysis we reviewed the Council Agenda Report, as well as the Proposed Resolution. We also discussed those documents with Agency staff.

Since our impartial financial analysis was not an audit, we did not apply Government Auditing Standards as published by the Comptroller General of the United States.

SUMMARY

The City of Oakland has provided case management services for frail, disabled senior residents since 1980. The current grant from the State provides funding to serve 350 such clients every month, and also pays for the salaries and administrative costs of Agency staff that are involved in case management.

Although the Council Agenda Report does not state how the entire \$1,352,467 will be spent, according to the grant award and Agency staff the funds will be spent follows:
