It has come to my attention that the term for my youth appointee to the Planning and Oversight Committee (POC) of the Oakland Fund for Children and Youth has expired.


I would like to appoint Ms. Marilyn Montenegro to fill this seat on the POC through July 31, 2004. A resume for Ms. Montenegro is attached.
