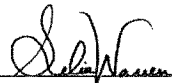

RESOLUTION NO. 90899 C.M.S.

RESOLUTION ACCEPTING AND APPROPRIATING THREE HUNDRED FORTY-ONE THOUSAND SEVENTY ONE DOLLARS (\$341,071) FOR MEDI-CAL RELATED ACTIVITIES THROUGH THE MEDI-CAL ADMINISTRATIVE ACTIVITIES (MAA) PROGRAM AND ACCEPTING AND APPROPRIATING ANY ADDITIONAL FUNDS THAT MAY COME AVAILABLE AND AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO A MAA MEMORANDUM OF UNDERSTANDING WITH ALAMEDA COUNTY HEALTH TO ALLOW FOR ADMINISTRATIVE REIMBURSEMENT TO THE CITY OF OAKLAND FOR PERFORMING MEDI-CAL ADMINISTRATIVE ACTIVITY, FOR FISCAL YEAR 2025-2026 AND EVERY FISCAL YEAR THEREAFTER

WHEREAS, the federal government allows local governments to be reimbursed for work that supports the identification and enrollment of individuals into the Medi-Cal program and their continued access to Medi-Cal services under the Medi-Cal Administrative Activities Program; and

WHEREAS, the City of Oakland's Human Services Department has the capacity, particularly through its senior services and homeless and hunger programs, to conduct such outreach, identification and on-going support to the Medi-Cal eligible population in Oakland; and

WHEREAS, the Human Services Department submitted an application to Alameda County Health Care Services Agency on August 8, 2002 to become authorized to apply for reimbursement under the Medi-Cal Administration Activities Program (MAA); and

WHEREAS, in 2004, the City of Oakland Human Services Department's MAA application and claiming plan was approved by Alameda County and is effective for Medi-Cal activities performed during the 2002-2003 fiscal year and for all subsequent years; and

WHEREAS, the Human Services Department wishes to participate in the MAA program so that it can expand and strengthen its outreach and support to the Medi-Cal eligible population in Oakland; and

WHEREAS, the Human Services Department expects a reimbursement amount up to \$341,071 for Medi-Cal related activities through the MAA program for fiscal year 2025-2026 and anticipates and hopes that roughly similar amounts will be available for reimbursement in future fiscal years; and

WHEREAS, in an effort to streamline this process and minimize the annual administrative burden on staff and the Council of this anticipated regular source of reimbursement funds, the Human Services Department recommends, subject to the limitations set forth in this Resolution, that a return to Council not be required unless the funding codes change; now, therefore, be it

RESOLVED: That the City Administrator is authorized to enter into a Memorandum of Understanding with Alameda County Health to allow for administrative reimbursement to the City of Oakland for performing Medi-Cal administrative activity as required by Alameda County Health and the California Department of Health services for fiscal year 2025-2026 and every fiscal year thereafter; and be it

FURTHER RESOLVED: The Council hereby accepts and appropriates \$341,071 for reimbursement for the Human Services Department for Medi-Cal Administrative Activities (MAA) Program for Medi-Cal-related activities to the State of California Fund (2159), Human Services Administration Organization (78111), Medi-Cal Admin Activities Project (1000323), and Empowering Seniors & People with Disability Program (YS14); for fiscal year 2025-2026 and every fiscal year thereafter; and be it

FURTHER RESOLVED: That the City Council hereby accepts and appropriates any additional funds that become available through the MAA Program for fiscal year 2025-2026 and every fiscal year thereafter, to the State of California Fund (2159), Human Services Administration Organization (78111), Medi-Cal Admin Activities Project (1000323), and Empowering Seniors & People with Disability Program (YS14), for Medi-Cal related activities of the Human Services Department.
