RESOLUTION NO. 90132 C.M.S.

INTRODUCED BY COUNCIL PRESIDENT NIKKI FORTUNATO BAS

RESOLUTION APPOINTING COMMUNITY MEMBER JOHN BEAM TO THE OAKLAND-ALAMEDA COUNTY COLISEUM AUTHORITY BOARD OF COMMISSIONERS TO COMPLETE THE TERM BEGINNING OCTOBER 8, 2023 AND ENDING OCTOBER 7, 2025.

WHEREAS, Section 4 of the Joint Exercise of Powers Agreement dated December 17, 1996 (Joint Powers Agreement) between the City of Oakland and Alameda County created the Oakland-Alameda County Coliseum Authority, whose members are appointed by the Oakland City Council and the Alameda County Board of Supervisors to serve two year terms; and

WHEREAS, Section 4 of the Joint Powers Agreement originally provided that the Oakland-Alameda County Coliseum Authority Board of Commissioners would consist of four members, two members of the City Council and two members of the Alameda County Board of Supervisors; and

WHEREAS, on February 9, 2001, pursuant to section 4 of the Joint Powers Agreement, the Board of Commissioners voted to add additional board members with two to be appointed by the City Council from members of the community; and

WHEREAS, City Charter section 601 authorizes the Mayor to appoint members of boards and commissions created by the Council, subject to confirmation by five members of the Council, except as otherwise provided by the City Charter, and the Joint Powers Authority is not a City board or commission; and

WHEREAS, Rule 6 of the Council's Rules of Procedure provides that, except for appointments reserved to the Mayor under the City Charter, the Council President shall recommend appointments to regional and local boards and agencies as appropriate subject to confirmation of the City Council by resolution, which requires five affirmative votes; and

WHEREAS, pursuant to Resolution No. 89132 CMS, the Council confirmed the appointment of Chuck Baker as a community member to the Joint Powers Authority Board for the term commencing on October 8, 2021 and ending on October 7, 2023; and

WHEREAS, John Beam is a prominent football coach who is currently Head Coach and Athletic Director at Laney College in Oakland, California. His remarkable coaching journey has featured a career spanning over 42 years and counting. John Beam has been head coach at Laney since 2012 and has been coaching at the school since 2004. He coached at Skyline High School in Oakland, California before joining the Laney coaching staff from 1982-2003. John Beam's impact on the football landscape is nothing short of extraordinary, he has consistently demonstrated a passion for nurturing talent and shaping young lives. In 2018, John Beam was honored as the California Community College Football Coach of the Year; now, therefore be it

WHEREAS, the Council President recommends that John Beam be appointed to the community member seat previously filled by Chuck Baker to complete the term beginning October 8, 2023 and ending October 7, 2025; now, therefore, be it

RESOLVED: That the following individual is hereby appointed to the Oakland-Alameda County Coliseum Authority Board of Commissioners:

- Community member John Beam to complete the term beginning October 8, 2023 and ending October 7, 2025.


