RESOLUTION AUTHORIZING THE APPLICATION FOR AND ACCEPTANCE OF A GRANT FROM THE STATE OF CALIFORNIA DEPARTMENT OF **COMMUNITY** SERVICES AND DEVELOPMENT (CSD) IN THE AMOUNT OF \$161,578 FOR THE OAKLAND COMMUNITY ACTION AGENCY TO ASSIST LOW INCOME PERSONS AND THOSE AFFECTED BY WELFARE REFORM DURING CALENDAR YEAR 2001

WHEREAS, the State of California Department of Community Services and Development has made available Community Services Block (CSBG) funds for year 2001; and

WHEREAS, the State of California Department of Community Services and Development (CSD) has offered Community Services Block Grant to the Oakland Community Action Agency (CAA); and

WHEREAS, the City of Oakland, on behalf of the Oakland Community Action Agency (CAA), is willing to apply for, accept and appropriate the aforementioned Grant in the amount of \$161,578, and offset the same amount of revenue, for the Program Year January 1, 2001 through December 31, 2001, under provisions of the Community Services Block Grant; and

WHEREAS, the grantor pays all central services overhead costs; and

WHEREAS, these hnds will be used by the Oakland Community Action Agency (CAA) to provide program administrative support and direct services to Oakland's low-income citizens affected by Welfare Reform; and

WHEREAS, the Oakland Community Action Agency Administering Board has approved extending the job training and development activities for Head Start parents and other low-income persons affected by Welfare Reform through December 31,2001; and

WHEREAS, services provided will be in accordance with CSD Sub-Grant provisions, regulation, and guidelines for eligible activities under the Community Services Block Grant; now, therefore, be it

RESOLVED: That the City Manager of the City of Oakland is hereby authorized and directed to negotiate and execute a contract with CSD to accept CSBG grant funds and offsetting revenue in the amount of \$161,578 for the purpose described above for program year 2001; and be it further

RESOLVED: That the City Council hereby authorizes the City Manager or his designee **as** agent for the City to negotiate and execute agreements with service providers for the purpose of providing services to eligible clients in the City of Oakland, and to conduct all **negotiations**, **execute and submit all documents**, **including but not limited to applications**, agreements, amendments, modifications, payment requests, terminations and related actions which may be necessary; and be it further

RESOLVED: That the City Council appoints the City Manager or his designee as agent of the City to accept and appropriate said grant and any additional funding that may become available.
