**AN ORDINANCE AMENDING ORDINANCE NUMBER 12477 C.M.S. (MASTER FEE SCHEDULE), AS AMENDED, TO ESTABLISH, MODIFY AND DELETE FEES ASSESSED BY THE DEPARTMENT OF CULTURAL ARTS AND MARKETING (KAISER CONVENTION CENTER, KTOP), COMMUNITY AND ECONOMIC DEVELOPMENT AGENCY, FIRE SERVICES AGENCY, POLICE SERVICES AGENCY, OFFICE OF THE CITY CLERK, OAKLAND PUBLIC LIBRARY, FINANCE AND MANAGEMENT AGENCY AND THE PUBLIC WORKS AGENCY**

**WHEREAS**, the City of Oakland periodically updates its Master Fee Schedule to account for *general cost of living increases and program changes or other costs*; and

**WHEREAS**, the fee modifications and additions proposed herein have been justified by the respective agencies and are identified in an "Agenda Report" dated June 5, 2003 to Robert C. Bobb, City Manager, entitled "An Ordinance Amending Ordinance Number 12477 C.M.S. (Master Fee Schedule), as Amended, to Establish, Modify, and Delete Fees Assessed by selected Offices, Departments, and Agencies of the City of Oakland"; and

**WHEREAS**, the City Council finds and determines that the herein-referenced modifications and additions are necessary to reimburse the City for the costs of performing the various municipal and regulatory functions; and

**WHEREAS**, a Public Hearing was held on June 5, 2003, to review the proposed fee changes;

**NOW THEREFORE**, the Council of the City of Oakland does hereby ordain as follows:

**Sections 1.** The Master Fee Schedule as set forth in Ordinance Number 12443 C.M.S., as amended, is hereby amended to modify and establish fees assessed by the Department of Cultural Arts and Marketing (Kaiser Convention Center, KTOP), Community and Economic Development Agency, Fire Services Agency, Police Services Agency, Office of the City Clerk, Oakland Public Library (AAMLO), Finance and Management Agency (Administration and Parking) and the Public Works Agency and as set forth in Exhibit A, attached hereto and made a part hereof.

**Section 2.** This ordinance shall be effective on July 1, 2003 upon approval by the Council of the City of Oakland.
