It should also be noted that Council Member Reid secured \$11 million in funding for the East Oakland Sports Center. This allocation exemplifies his dedication to creating spaces that enhance the lives of East Oakland residents, particularly our youth.

I urge the Commission to honor former Council Member Reid's decades of service and lasting impact on our community by naming the East Oakland Sports Center after him. This recognition would serve as a lasting reminder of his contributions and inspire future generations to continue his legacy of community service and development.
