Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends settlement of the above-entitled claim for the sum of Fourteen Thousand Four Hundred Forty Seven Dollars and 95 Cents (\$14,447.95), payable to Totally Helen, LLC as a result of flooding caused by a plugged storm drain inlet and poor drainage from City Streets. On December 29, 2003, during a heavy rainstorm water runoff from City streets overflowed onto the Totally Helen, LLC property causing damages. (Public Works Agency) This is not a closed session item.
