RESOLUTION AUTHORIZING THE CITY MANAGER TO EXTEND THE AGREEMENT WITH IS SOLUTIONS, INC. TO LEASE THE COMPAQ ALPHA 8400 SERVER FOR A TOTAL PERIOD OF ONE YEAR, AND INCREASING THE AMOUNT BY SIXTY THOUSAND DOLLARS (\$60,000.00) FOR A CONTRACT TOTAL NOT TO EXCEED ONE HUNDRED TEN THOUSAND DOLLARS (\$110,000.00)

WHEREAS, the City of Oakland entered into an agreement dated July 28, 2000 with IS Solutions Inc. for the lease of a COMPAQ ALPHA 8400 Server, essential computer equipment necessary to improve the performance of the City of Oakland's Oracle applications; and

WHEREAS, IS Solutions Inc. was selected to deliver the COMPAQ Server based on its ability to expedite delivery of the equipment, and provide the equipment at the lowest lease and maintenance price; and

WHEREAS, the initial term of the lease was for 6 months, and it is in the City's best interests to continue the lease for an additional 6 months because the City's replacement server has not yet been acquired or installed and the City must maintain continuous operation of its Oracle applications; and

WHEREAS, pursuant to Oakland Municipal Code section 2.040.050 I(5), the City Council may waive formal bidding requirements when it is in the best interests of the City to do so; and

WHEREAS, the City lacks the equipment and personnel to perform the necessary computer system functions and services; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the City's best interests because of economy; and

WHEREAS, the City Council finds that this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

RESOLVED: Pursuant to Oakland Municipal Code Title 2, section 2.040.050 I(5), the City Council finds and determines that it is in the best interest of the City to waive the formal bidding requirements and hereby authorize the City Manager or his designee to extend the existing contract with **IS Solutions Inc.** to increase the lease period on the Compaq Alpha 8400 Server to a total period of one year, and to increase the contract price in **an** amount of sixty thousand dollars (\$60,000) for a total amount not to exceed one hundred ten thousand dollars (\$110,000).
