**RESOLUTION NO. \_\_\_\_\_ C.M.S.**

**RESOLUTION APPOINTING DONNEKA L. WEBSTER AS A MEMBER OF THE OAKLAND HOUSING AUTHORITY BOARD OF COMMISSIONERS**

**WHEREAS**, the City Council adopted Resolution No. 6341 C.M.S. pursuant to the California Health and Safety Code, which authorizes the City of Oakland to declare the need for a housing authority by adopting such a resolution and authorizes the Mayor, subject to confirmation of a majority of the members of the governing body, to appoint five commissioners for terms of four years and two additional tenant commissioners for terms of two years; and

**WHEREAS**, Resolution No. 6341 C.M.S. specifies that the Oakland Housing Authority Board of Commissioners shall consist of seven members, five of which members are to serve four year terms, which are to be staggered so that some appointments will expire every year, and appointments to fill a term of office are only to be for the remainder of that term, and two of which members are to be tenants of the housing authority who are to serve two-year terms; provided that one tenant commissioner shall be over 62 years of age if the authority has tenants of such age; now, therefore, be it

**RESOLVED**, that by the nomination of the Mayor, the following individual is hereby appointed to serve as a tenant commissioner for the term set forth below:

Donneka L. Webster, as a Mayoral appointment to serve the term beginning July 1, 2006 and ending June 30, 2008, filling the position formerly held by Jacqueline Taylor.
