RESOLUTION NO. 90184 C.M.S.

INTRODUCED BY COUNCILMEMBER DAN KALB AND COUNCIL PRESIDENT
NIKKI FORTUNATO BAS

RESOLUTION OPPOSING THE TAXPAYER PROTECTION AND GOVERNMENT ACCOUNTABILITY ACT WHICH WOULD (1) JEOPARDIZE FUNDING FOR LOCAL SERVICES, (2) ENCOURAGE FRIVOLOUS LAWSUITS, (3) UNDERMINE VOTING RIGHTS, AND (4) ALLOW WEALTHY CORPORATIONS TO AVOID PAYING THEIR FAIR SHARE IN TAXES

WHEREAS, an association representing California's wealthiest corporations is spending tens of millions of dollars to promote a deceptive ballot measure currently eligible for the November 2024 statewide ballot; and

WHEREAS, the measure is deceptively titled the Taxpayer Protection and Government Accountability Act; and

WHEREAS, the measure creates constitutional loopholes that allow corporations to pay far less than their fair share for the impacts they have on our communities, which could force residents and taxpayers to pay more to maintain services; and

WHEREAS, the measure threatens billions of dollars every year in local government funding for services like fire and emergency response, law enforcement, affordable housing, services to support homeless residents, mental health services, and more; and

WHEREAS, the City of Oakland has faced significant budget cuts in the last year, balancing out a 360-million-dollar deficit; and

WHEREAS, the City of Oakland needs as much flexibility as possible to raise revenue to fund crucial services that address the issues of public safety, housing affordability and homelessness, economic development for small businesses and much more; and

WHEREAS, the measure is an attack on voters' rights, containing undemocratic provisions that would make it more difficult for local voters to pass measures to fund services, provisions that retroactively cancel measures recently passed by voters, and provisions that

prevent voters from passing advisory measures that provide direction on how they want their local tax dollars spent; and

WHEREAS, Measures T and Y, passed by voters in 2022, would be vitiated by this measure and would needlessly need to be taken back to voters once again; and

WHEREAS, the measure contains intentionally restrictive language that will encourage hundreds of frivolous lawsuits against cities and local governments – costing taxpayers many millions and stopping investments in vital local services; and

WHEREAS, the measure would make it much more difficult for state and local regulators to issue fines and levies on corporations that violate laws intended to protect our environment, public health and safety, and our neighborhoods; and

WHEREAS, the measure is opposed by hundreds of local governments, teachers, firefighters, working families and local elected officials; now, therefore let it be

RESOLVED: That the City of Oakland opposes the deceptively titled Taxpayer Protection and Government Accountability; and be it

FURTHER RESOLVED: That the City of Oakland will join the “Stop the Taxpayer Deception Act” coalition, a growing coalition of public safety, education, labor, local government, and infrastructure groups throughout the state; and be it


