A RESOLUTION APPOINTING COLLAND JANG AND CHRISTOPHER TOM AS THE CITY OF OAKLAND REPRESENTATIVES AND WILLIE YEE AS AN ALTERNATE REPRESENTATIVE ON THE OAKLAND CHINATOWN ADVISORY COMMITTEE, PER THE SETTLEMENT AGREEMENT IN THE MATTER OF THE CITY OF OAKLAND V. CITY OF ALAMEDA POINT (ALAMEDA COUNTY SUPERIOR COURT NO. RG-03133599), BETWEEN THE CITY OF OAKLAND, CITY OF ALAMEDA, ASIAN HEALTH SERVICES AND THE OAKLAND OAKLAND CHINATOWN CHAMBER OF COMMERCE (ALAMEDA POINT GENERAL PLAN AMENDMENT).

WHEREAS, On April 6, 2004, the Oakland City Council adopted Resolution No. 78445 C.M.S. to settle City of Oakland v. City of Alameda (Alameda County Superior Court No. RG-03133599); and

WHEREAS, the settlement agreement (Settlement Agreement) was executed by the City of Oakland, City of Alameda, the Oakland Chinatown Chamber of Commerce (OCCC), and Asian Health Services (AHS); and

WHEREAS, the Settlement Agreement requires Alameda to contribute \$75,000 to establish and administer an Oakland Chinatown Advisory Committee (OCAC) and \$500,000 for traffic and pedestrian safety improvements for Oakland Chinatown when Alameda issues permits for Phase I of the Alameda Point development project; and

WHEREAS, the Settlement Agreement requires the City of Oakland to provide a matching \$462,000 for traffic and pedestrian safety improvements for Chinatown; and

WHEREAS, the Settlement Agreement calls for the City of Alameda and the City of Oakland to establish the OCAC to serve as an advisory committee to the Alameda City Council and Planning Board and the Oakland City Council and Planning Commission for the purpose of providing ongoing communication and feedback on Oakland Chinatown issues related to future development and environmental review (CEQA) process for projects within Alameda Point and Downtown Oakland; and

WHEREAS, the Settlement Agreement specifies that the OCAC shall consist of four representatives and one alternate representative from the Oakland Chinatown Community to be selected by OCCC and AHS, two representatives and one alternate selected by the Oakland City Council, and two representatives and one alternate selected by the Alameda City Council; and

WHEREAS, Colland Jang is a local architect based in Oakland Chinatown and member of the City's Planning Commission, Christopher Tom is a legislative aide to Councilmember Danny Wan who represents the Chinatown neighborhood, and Willie Yee is the senior advisor to Councilmember At-Large, Vice Mayor Henry Chang, Jr.; now, therefore be it
