RESOLUTION NO. 76247 C. M.S.

RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A GRANT AGREEMENT WITH THE OAKLAND UNIFIED SCHOOL DISTRICT IN AN AMOUNT NOT TO EXCEED \$100,000 FOR FISCAL YEAR 2000-01 TO SUPPORT IMPROVEMENTS TO THE OUSD PUBLIC SAFETY ACADEMY AND TO INCREASE OAKLAND RESIDENTS ENROLLMENT IN THE CADET PROGRAM

WHEREAS, the Oakland Unified School District operates a Public Safety Academy at Castlemont High School that is designed to expose young people to careers in public safety; and

WHEREAS, the City of Oakland desires to increase the enrollment and successful graduation of Oakland youth in the Oakland Police Cadet Program; and

WHEREAS, the City Council appropriated \$100,000 (Org. 47121, Fund 1010, Account No. 53719) in each fiscal year for the 1999-01 adopted budget specifically to support enhancements to the OUSD Public Safety Academy for the purpose of and in order to increase the enrollment of Oakland residents in the Oakland Police Cadet Program; and

WHEREAS, the Oakland Unified School District in partnership with the Oakland Police Department is prepared to implement improvements to the OUSD Public Safety Academy starting with the September 2000 school program and therefore will only use the one year allocation of \$100,000 during the two year budget cycle 1999-01; now therefore, be it

RESOLVED: That the City Council hereby authorizes the City Manager or his designee to enter into a grant agreement with the Oakland Unified School District in an amount not to exceed \$100,000 for fiscal year 2000-01 to provide enhancements to the OUSD Public Safety Academy; and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment **requests**, and related actions which may be necessary in accordance with its basic purpose, at no additional contract costs; and be it

FURTHER RESOLVED: That the Office of the City Attorney has approved this resolution as to form and legality and a copy is on file at the Office of the City Clerk.
