ORDINANCE 1) CALLING AND GIVING NOTICE FOR THE HOLDING OF THE MUNICIPAL NOMINATING ELECTION ON JUNE 7, 2022 FOR THE PURPOSE OF SUBMITTING TO THE ELECTORS OF THE CITY OF OAKLAND A PROPOSED BALLOT MEASURE; 2) REQUESTING CONSOLIDATION OF THE CITY OF OAKLAND MUNICIPAL NOMINATING ELECTION WITH THE STATEWIDE ELECTION TO BE HELD IN THE CITY OF OAKLAND ON JUNE 7, 2022; AND 3) AUTHORIZING AND DIRECTING THE CITY CLERK TO TAKE ALL ACTIONS NECESSARY FOR THE MUNICIPAL ELECTION IN ACCORDANCE WITH APPLICABLE LEGAL REQUIREMENTS

This Ordinance provides notice of a Municipal Nominating Election in the City of Oakland on June 7, 2022 for the purpose of submitting to the electors of the City of Oakland a proposed ballot measure. This Ordinance also requests consolidation of the Municipal Nominating Election with the Statewide Primary Election to be held on the same day. This ordinance authorizes the City Clerk of the City of Oakland to take all actions necessary for the Municipal Nominating Election in accordance with applicable legal requirements.
