### RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENTS OF MEMBERS OF THE OAKLAND TAXATION AND ASSESSMENT BOARD OF REVIEW UNDER THE TRANSIENT OCCUPANCY TAX ORDINANCE

**WHEREAS**, City of Oakland ("City") Charter Section 601 provides, among other things, that the City Council may create by ordinance advisory, appellate or rule-making boards and commissions and prescribe their function, duties, powers, and jurisdiction, and that members of boards and commissions shall be appointed by the Mayor, subject to confirmation by the affirmative vote of five members of the City Council ("Council"); and

**WHEREAS**, pursuant to Oakland Municipal Code Section 4.24.100(A), the Taxation and Assessment Board of Review under the Transient Occupancy Tax Ordinance ("TOT Board") is comprised of, among others, the City Manager (also known as the City Administrator), the City Auditor, and two community members nominated by the Mayor and appointed by the Council for a term of four years; and

**WHEREAS**, pursuant to Oakland Municipal Code Section 4.24.100(A), the City Administrator and the City Auditor may each designate a person to serve as his/her designee to the TOT Board; now, therefore, be it

**RESOLVED:** That the City Council hereby confirms the Mayor's appointment of the following individuals to the TOT Board as set forth below:

1. The City Auditor.
2. The City Administrator.
3. Charles L. "Chip" Conradi, as a Mayoral appointment to serve the term that began October 2, 2019 and ending October 1, 2023, filling the seat designated for a community member selected by the Mayor.
4. Jens Hillmer, as a Mayoral appointment to serve the term that began October 2, 2020 and ending October 1, 2024, filling the seat designated for a community member selected by the Mayor; and be it

**FURTHER RESOLVED:** That this resolution shall take effect immediately upon passage.


