RESOLUTION NO. 911723 C.M.S.

RESOLUTION:

- 1) **AUTHORIZING THE CITY ADMINISTRATOR TO SIGN AND EXECUTE AN AGREEMENT WITH THE CALIFORNIA DEPARTMENT OF HEALTH CARE SERVICES (DHCS) AND ITS THIRD-PARTY ADMINISTRATOR RELATED TO THE CALIFORNIA PROVIDING ACCESS AND TRANSFORMING HEALTH (PATH) CAPACITY AND INFRASTRUCTURE, TRANSITION, EXPANSION AND DEVELOPMENT (CITED) PROGRAM INTERGOVERNMENTAL TRANSFER (IGT) AWARD TO IMPLEMENT THE CALAIM-READY OAKLAND PROJECT AND DELIVER ENHANCED CARE MANAGEMENT AND COMMUNITY SUPPORTS FOR HIGH-NEED MEDICAL POPULATION IN OAKLAND;**
- 2) **ACCEPTING AND APPROPRIATING THE DHCS PATH CITED IGT AWARD IN AN AMOUNT NOT TO EXCEED \$1,351,113.75, WHICH REQUIRES NON-FEDERAL LOCAL SHARE EQUAL TO FIFTY PERCENT OF THE AWARD; AND**
- 3) **AUTHORIZING THE CITY TO COMMIT THE REQUIRED NON-FEDERAL LOCAL SHARE EQUAL TO FIFTY PERCENT OF THE TOTAL DHCS IGT AWARD IN THE AMOUNT OF \$675,556.75 IN ORDER TO DRAW DOWN THE CORRESPONDING FEDERAL MATCH FROM DHCS**

WHEREAS, the California Department of Health Care Services (DHCS) administers the California Providing Access and Transforming Health (PATH) Initiative, including the Capacity and Infrastructure, Transition, Expansion and Development (CITED) Program; and

WHEREAS, the City of Oakland is an eligible local government entity under the CITED Program Intergovernmental Transfer (IGT) program; and

WHEREAS, the City of Oakland has been awarded one million three hundred fifty-one thousand one hundred thirteen dollars and seventy-five cents (\$1,351,113.75) under the PATH

CITED IGT program to support the CalAIM-Ready Oakland project to expand Enhanced Care Management and Community Supports services subject to a fifty percent (50%) match requirement; and

WHEREAS, receipt of funds requires the City to provide a non-federal local contribution equal to fifty percent (50%) of the total award amount in order to draw down the corresponding federal match; and

WHEREAS, the fifty percent (50%) match funds in the amount of six hundred seventy-five thousand five hundred fifty-six dollars and seventy-five cents (\$675,556.75) are available from various City funds as set forth in Table 1 and staff has confirmed and verified that all fund sources are eligible for local matches, below; and

WHEREAS, the City Council desires to accept these funds and authorize execution of the necessary agreements to improve access to coordinated health and social services for high-need Medi-Cal beneficiaries; and

WHEREAS, unless DHCS allows otherwise, all funds will be expended within the grant term of January 1, 2026 through December 31, 2026 and must be used in accordance with the approved project plan, program guidance, and DHCS terms and conditions (Attachment A); now, therefore, be it

RESOLVED: That the City Council of the City of Oakland hereby authorizes the City Administrator to execute an agreement with the California Department of Health Care Services and its third-party administrator related to the California Providing Access and Transforming Health (PATH) Capacity and Infrastructure, Transition, Expansion and Development (CITED) Program Intergovernmental Transfer (IGT) award to implement the CalAIM-Ready Oakland project and deliver Enhanced Care Management and Community Supports for high-need Medi-Cal population in Oakland; and be it

FURTHER RESOLVED: That the Council accepts and appropriates the DHCS PATH CITED IGT award in the amount not to exceed one million three hundred fifty-one thousand one hundred thirteen dollars and seventy-five cents (\$1,351,113.75) within the following funding code: State of California Fund (2159), Senior Center Organization (75631), Project (TBD), and Empowering Seniors with Disability Program (YS14), which requires non-federal local share equal to fifty percent (50%) of the award; and be it

FURTHER RESOLVED: That Council authorizes the City to commit the required non-federal local share equal to fifty percent (50%) of the award in the amount of six hundred seventy-five thousand five hundred fifty-six dollars and seventy-five cents (\$675,556.75) to draw down the corresponding federal match from DHCS. The City's local match will be covered by City funds as provided in Table 1, below.
