A Resolution Confirming the Council President's Appointment of Members and the Chairpersons of the Community and Economic Development, Public Works, Life Enrichment, Finance and Management, Public Safety, Rules and Legislation, and Education Partnership Committees of the City Council

WHEREAS, Rule 4 of the Council's Rules of Procedure Resolution No. 82580 C.M.S., entitled "Standing Committees, provides that the President of the Council, subject to confirmation by Council resolution, shall appoint all committees; and

WHEREAS, Rule 4 further provides that Committee chairs shall be appointed by the Council President and confirmed by City Council resolution for a two-year term beginning in January with each new City Council term; and

WHEREAS, Rule 4 provides that the subject matter standing committees of the Council shall consist of the following: Community and Economic Development, Public Works, Life Enrichments, Finance and Management, Public Safety, and Rules and Legislation Committees; and

WHEREAS, Rule 4 provides that the Council may establish such other ad hoc or standing committees as it deems appropriate (e.g. City/Port Liaison Committee and the Education Partnership Committee) and that a majority of the members of the Council may direct the appointment of a committee by the Council President; now therefore be it
