INTRODUCED BY COUNCIL MEMBER REBECCA KAPLAN, COUNCIL PRESIDENT NIKKI FORTUNATO BAS, AND COUNCIL MEMBER CARROLL FIFE

RESOLUTION AWARDING A GRANT AGREEMENT WITH THE INTERFAITH COUNCIL OF ALAMEDA COUNTY IN AN AMOUNT NOT TO EXCEED \$450,000 TO PROVIDE ONE OR MORE SAFE PARKING PROGRAMS FOR PERSONS LIVING IN VEHICLES FOR A GRANT TERM COMMENCING ON JANUARY 1, 2024 AND ENDING DECEMBER 31, 2024, UTILIZING FUNDS FROM MEASURE Q FUND BALANCE (FUND 2244) AND MAKING CALIFORNIA ENVIRONMENTAL QUALITY ACT FINDINGS

WHEREAS, based on the 2022 Point-In-Time Count for Alameda County, approximately 3,337 individuals are living outside and unsheltered in the City of Oakland at any given time; and

WHEREAS, approximately 86% of homeless individuals in Oakland resided in Alameda County prior to homelessness; and

WHEREAS, many homeless individuals and families in Oakland are living in their vehicles; and

WHEREAS, the City wishes to provide funding to the Interfaith Council of Alameda County, a nonprofit organization, ("ICAC") to provide approximately three safe parking programs for persons living in their vehicles to supplement existing homeless interventions; and

WHEREAS, the City has engaged in discussions with faith leaders who have organized as the ICAC ("Grantee") to operate safe parking programs at various sites for unsheltered persons in Oakland who are living in their vehicles; and

WHEREAS, the safe parking programs will be on sites owned or controlled by local faith-based organizations, and the Grantee's programs provide portable toilets, wash stations, access to showers, and wastewater dumping; and

WHEREAS, concurrently with this Resolution, City Council will appropriate funds from

Measure Q Fund (2244) and allocate \$1,578,000 to homeless services; therefore, funds are available for this award for the grant term; and

WHEREAS, the City desires to execute a grant agreement with the Interfaith Council of Alameda County in an amount not to exceed \$450,000 to operate safe parking sites with their faith-based partners; now, therefore, be it

RESOLVED: That the City Council authorizes the City Administrator to enter into a grant agreement with the Grantee in an amount not to exceed \$450,000 to provide safe parking programs for persons living in vehicles for a grant term commencing January 1, 2024, and ending December 31, 2024, provided that the agreement includes scope of work, performance metrics, and timelines for evaluation for the homeless service providers, and that the City Administrator or designee must terminate or may not extend the agreements following an initial six-month period unless the City Administrator or designee makes a determination that the service provider has met the conditions included in the agreement, and be it

FURTHER RESOLVED: That the City Council authorizes the City Administrator to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests, and related actions which may be necessary for the above-referenced grant agreement without returning to Council; and be it

FURTHER RESOLVED: That the grant agreement shall be reviewed as to form and legality by the Office of the City Attorney and copies will be filed in the Office of the City Clerk; and be it

FURTHER RESOLVED: That the City Council hereby finds and determines that the actions authorized under this Resolution and the subsequent operation and administration of safe parking sites, are exempt from additional review and analysis under the California Environmental Quality Act ("CEQA") and the CEQA Guidelines (Cal. Code Regs., title 14, section 15000 et seq: "CEQA Guidelines") under CEQA Guidelines section 15303, "New Construction or Conversion of Small Structures," and/or section 15304, "Minor Alterations to Land," and/or section 15311, "Accessory Structures," and/or section 15332, "In Fill Development Projects."
