The clients served were manufacturers, real estate developers, professional service organizations, restaurants and distributors. After graduate school, my tax practice expanded in the corporate, partnership, fiduciary and individual areas. I have experience in retirement plans and estate and gift plans.

During this time, I had the opportunity to teach accounting at the College of Alameda, to testify as an expert witness, to be appointed as a special master by the Superior Court, to prepare court accountings and to represent my clients before tax agencies. My accounting experience prior to 1970 involved learning the basics of auditing and taxation as a staff accountant.

I was a member of the California Army National Guard from 1962 through 1968 and received an honorable discharge.
