RESOLUTION NO. 90507 C.M.S.

**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH ALAMEDA COUNTY EMERGENCY MEDICAL SERVICES (EMS) FOR THE PROVISION OF MEDICAL EQUIPMENT, INCLUDING AUTOMATED EXTERNAL DEFIBRILLATORS (AEDS) AND OTHER EMERGENCY MEDICAL SUPPLIES, AND FOR DATA SHARING RELATED TO MEDICAL EMERGENCY RESPONSES**

**WHEREAS** the Oakland Police Department is committed to enhancing public safety and readiness during medical emergencies, and medical equipment such as AEDs are critical for providing immediate assistance during cardiac arrests; and

**WHEREAS** Alameda County EMS has partnered with Avive AED to distribute medical equipment and will extend this agreement to include the provision of additional life-saving equipment such as first aid kits and oxygen systems; and

**WHEREAS** the City of Oakland and Alameda County EMS will enter into a Memorandum of Understanding (MOU) that provides for the deployment, training, and maintenance of this medical equipment, and includes a data-sharing element to improve the coordination and analysis of medical emergency responses; and

**WHEREAS** Alameda County EMS will maintain the medical equipment provided, including regular inspections and necessary replacements, at no cost to the City of Oakland; and

**WHEREAS** the data-sharing program between OPD and Alameda County EMS will allow both agencies to exchange and analyze information related to medical emergencies where the equipment is utilized, improving the effectiveness of response and coordination; now therefore be it

**RESOLVED:** That the City Administrator is authorized to enter into a Memorandum of Understanding with Alameda County EMS to provide medical equipment, including AEDs and other life-saving tools, to the Oakland Police Department, and to engage in data sharing regarding medical emergencies where this equipment is used; and be it

**FURTHER RESOLVED:** That Alameda County EMS shall be responsible for the maintenance and upkeep of the medical equipment provided under this MOU, including inspections and necessary replacements; and be it

**FURTHER RESOLVED:** That OPD and Alameda County EMS will share data related to the use of medical equipment during emergency responses, with OPD retaining control over the data shared, ensuring compliance with all city regulations; and be it

**FURTHER RESOLVED:** That the agreement authorized by this resolution shall be approved as to form and legality before execution, and a copy of the fully executed agreement shall be placed on file with the Office of the City Clerk.


