# Oakland Public Works - Illegal Dumping Report

Illegal dumping is a critical issue throughout the City of Oakland (City).

The hardest hit areas are the city's frontline communities.

Significant economic, environmental, health, and safety impacts.



# Oakland Public Works - Illegal Dumping Report

Majority of the City's illegally dumped materials are removed by the **Illegal Dumping Unit (IDU)** in Oakland Public Works, Keep Oakland Clean and Beautiful Division.

The IDU is divided into **3 types of crews:**

- **Reactive** - Responds to service requests received by Oak311 or the "See Click Fix" application.
- **Proactive Crew (Garbage Blitz)** – Deployed to "hot spots" and major corridors to remove debris before it is reported.
- **Homeless Encampment** - Provide trash and debris for homeless encampment cleanings and closures. Works in coordination with the Encampment Management Team (EMT), led by the City Administrator's Office (CAO).
- The **Reactive** and **Proactive** Crews work in **4 Zones**

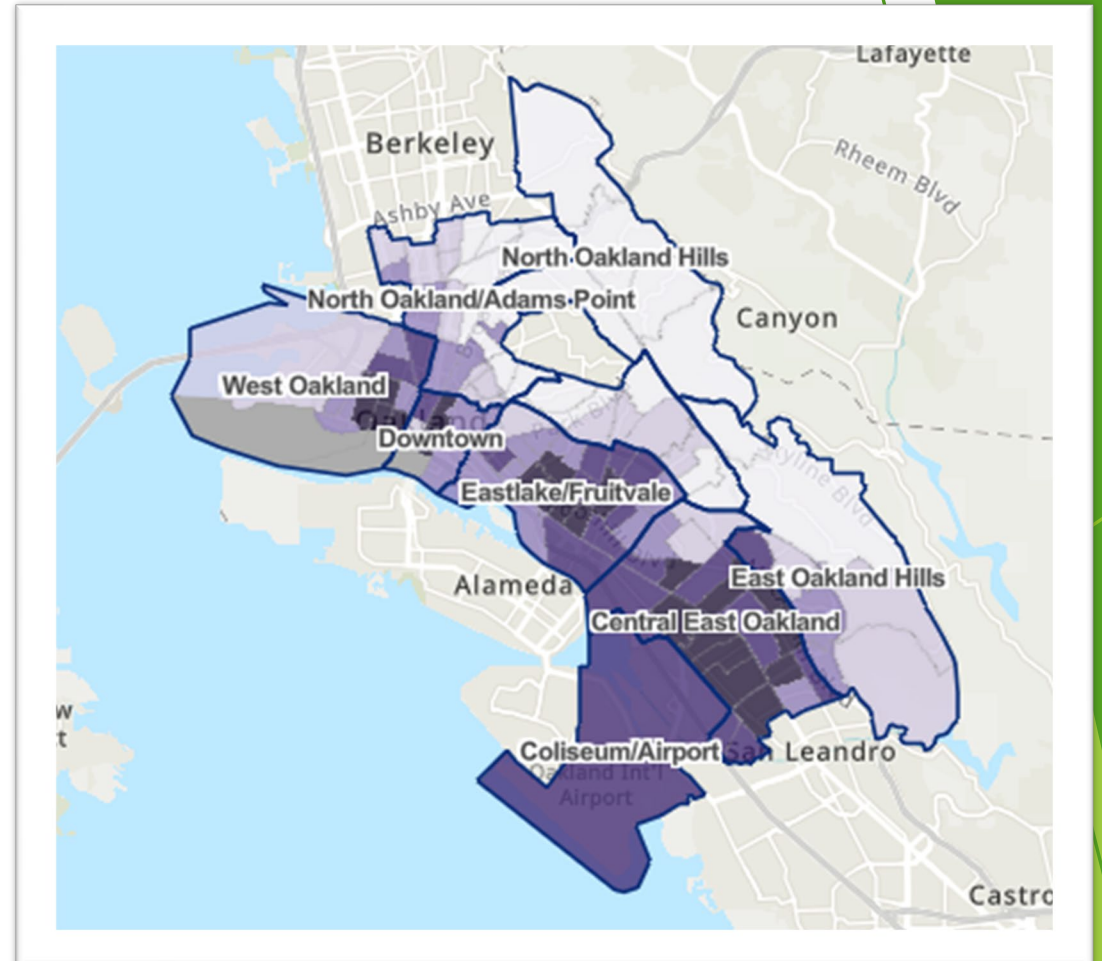
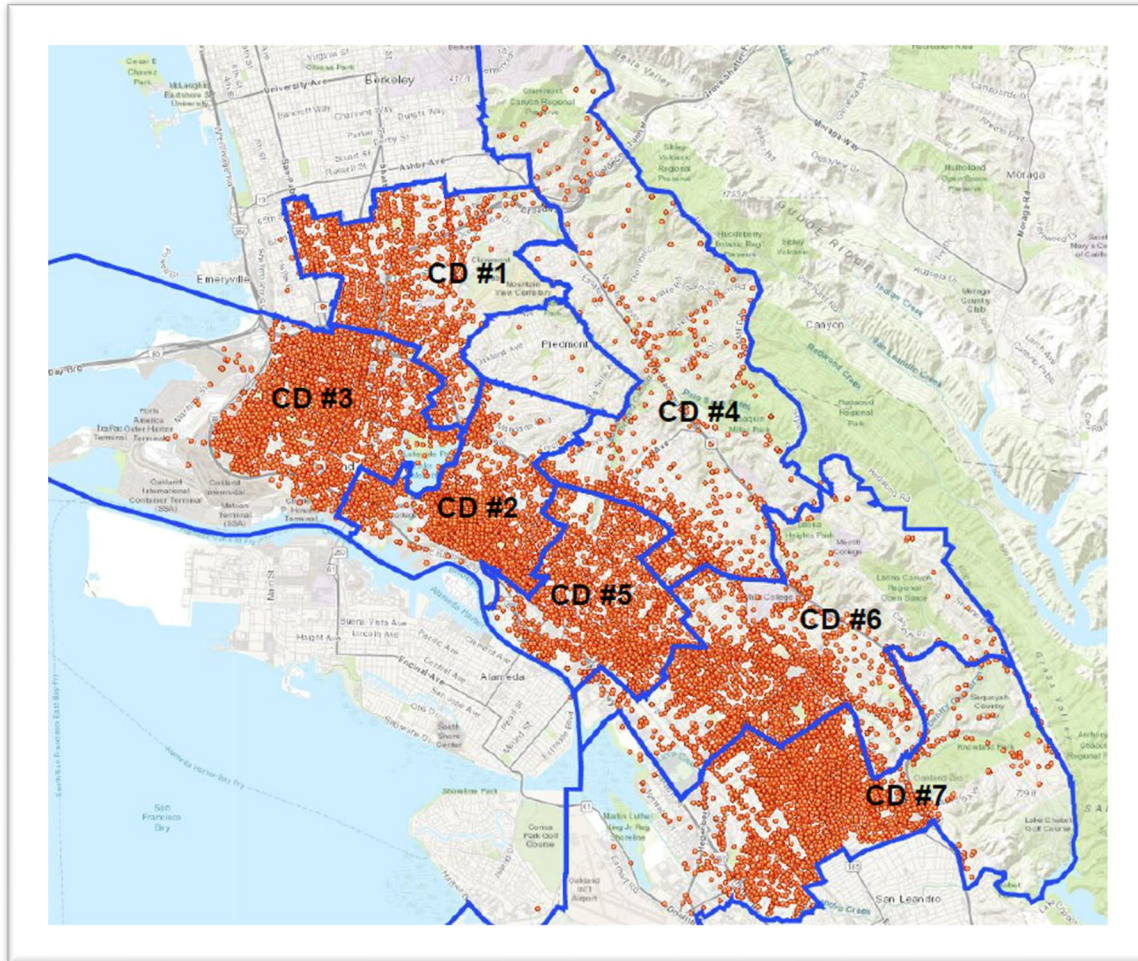
- KOCB crews complete thousands of illegal dumping service requests and work orders each year.
- Proactive work and encampment cleanings generate Work Orders, therefore there are more total Work Orders per year than Service Requests



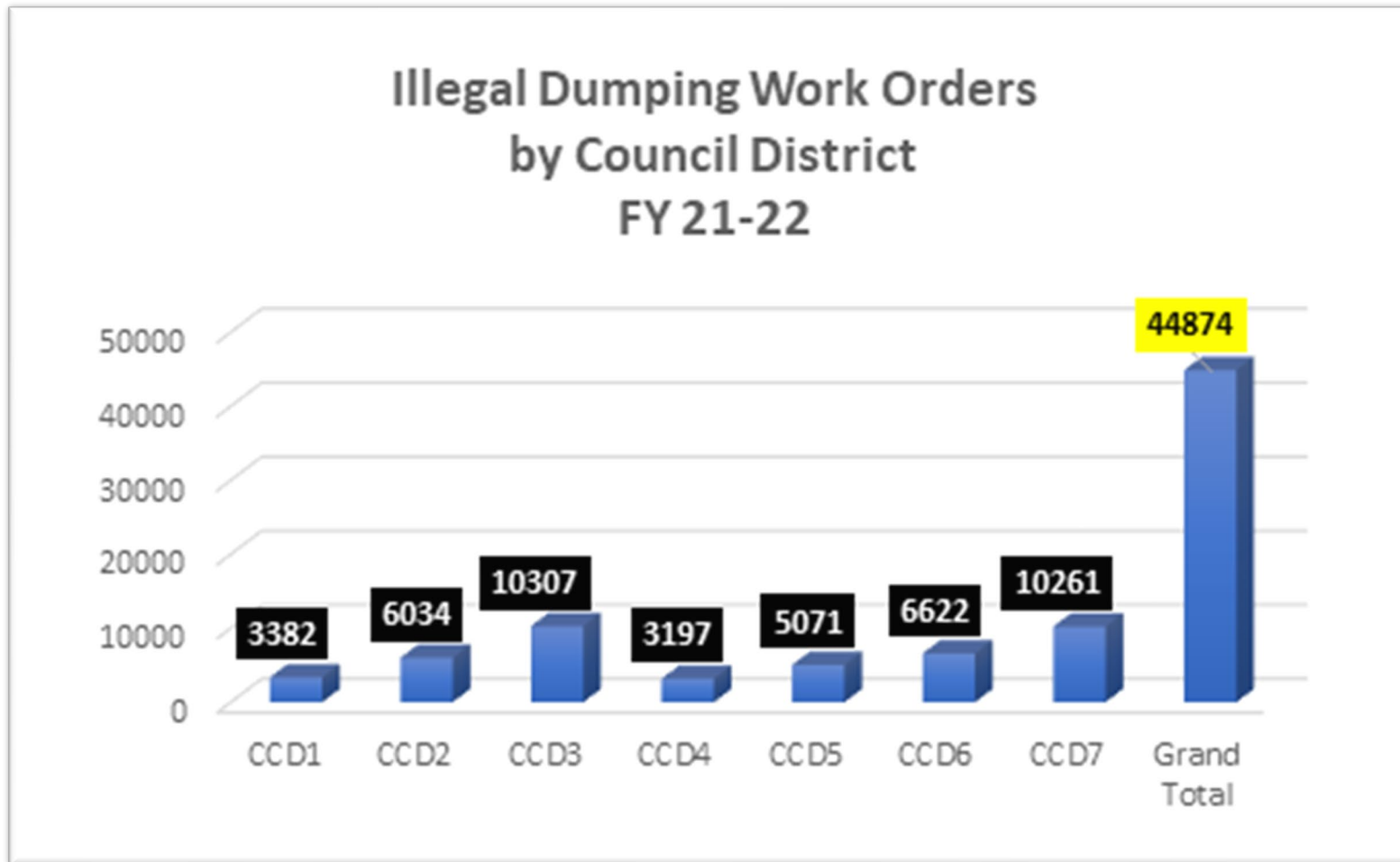

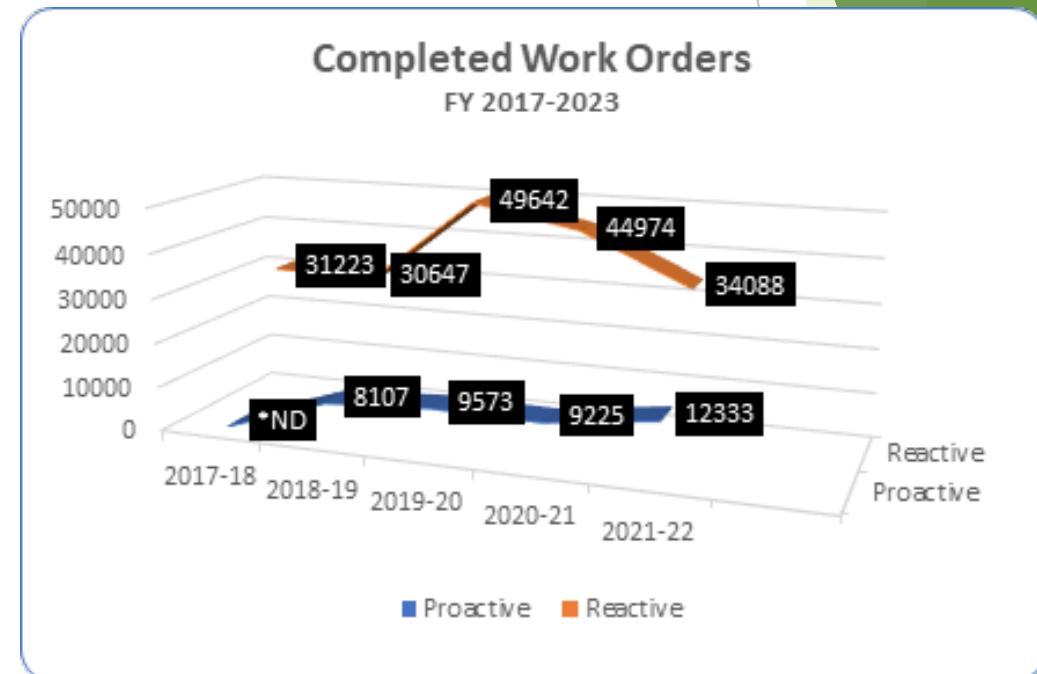
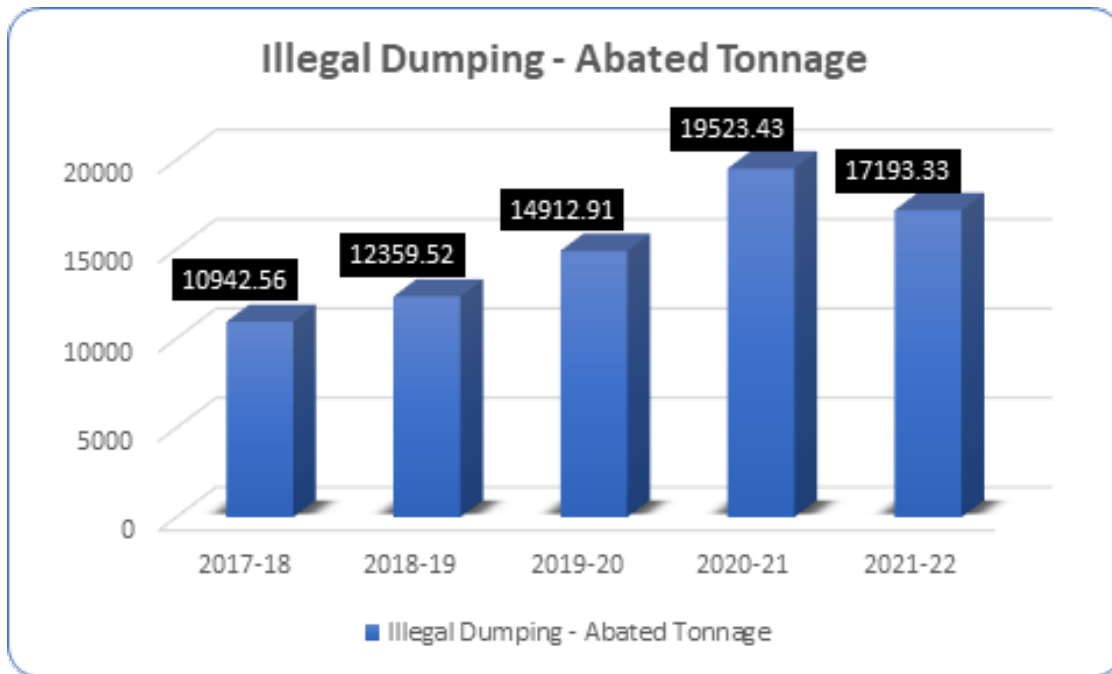

## Illegal Dumping Volumes

The quantity of illegal dumping removed by crews has increased significantly in the past five years. Work is shifting to proactive crews.

# of Encampments Closed in 22-23

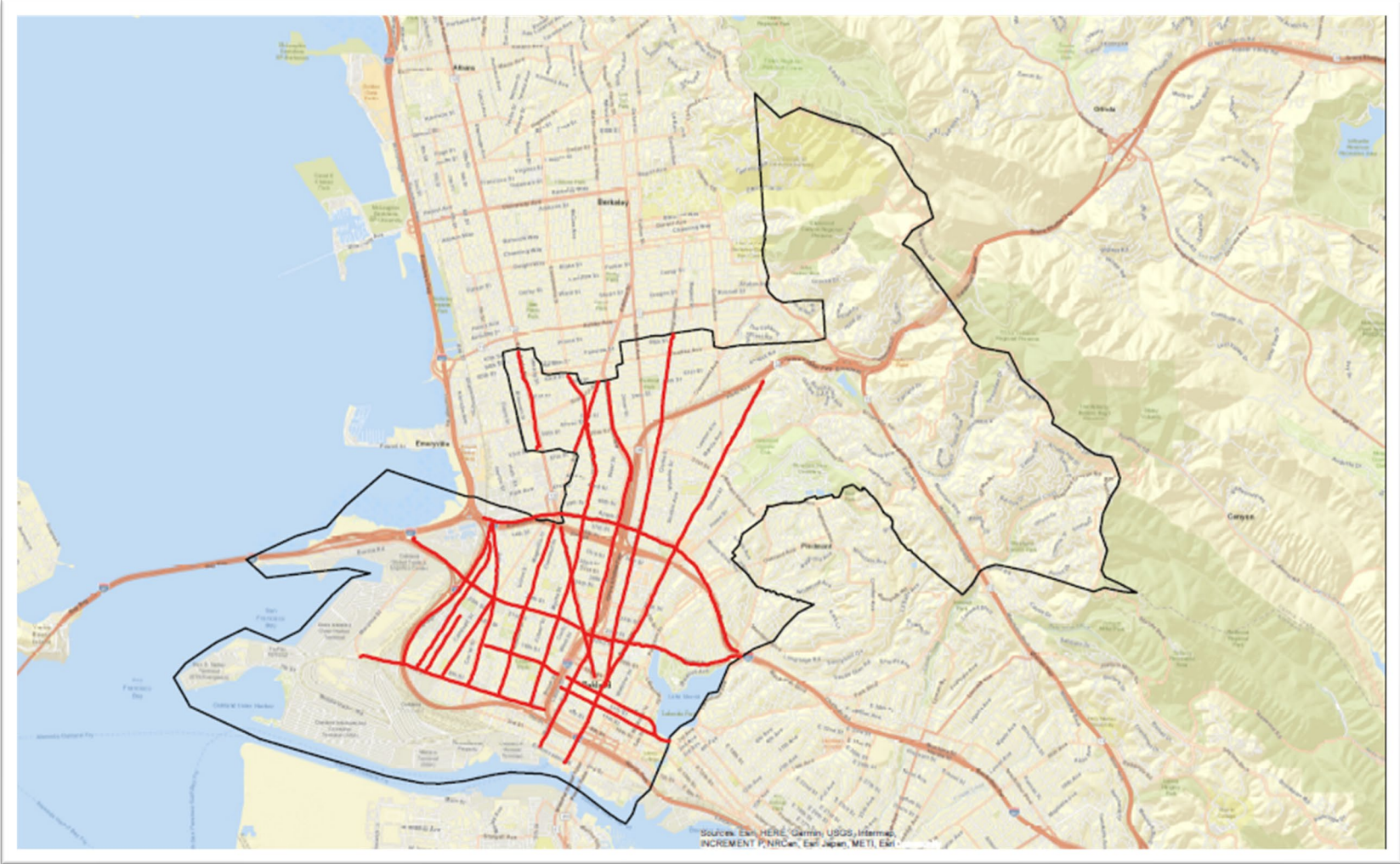


# Oakland Public Works - Illegal Dumping Report

- The **Reactive** and **Proactive** crews work in **4 Zones**
- Proactive crews patrol zone routes 6 days a week – rotating through each zone one at a time.
- Depending on cleanliness of zone, crews may stay in one zone from 2-5 days.

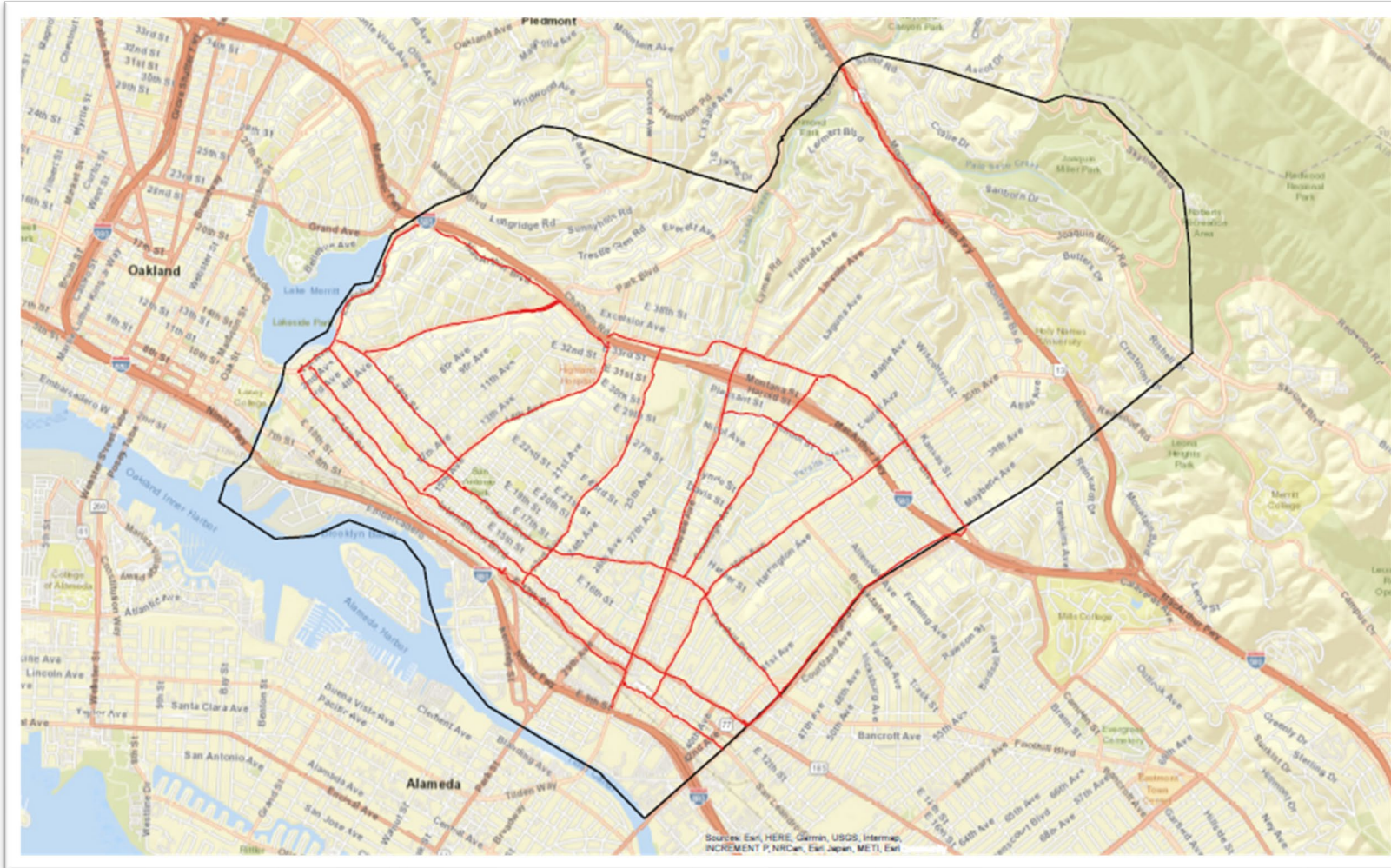


**Zone 1: Berkeley Border to Lake Merritt, includes Districts 1 and 3**



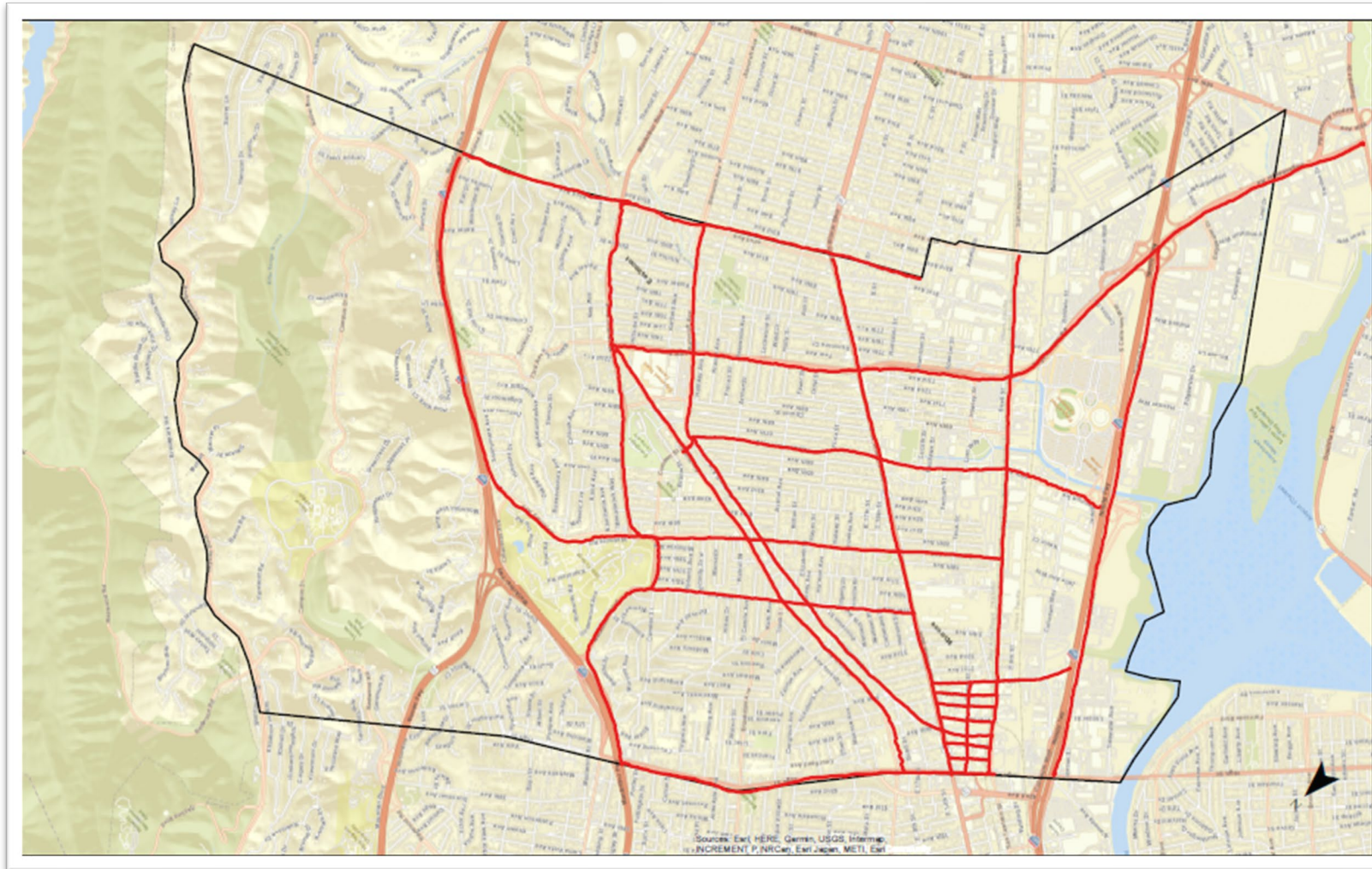


## Zone 2: Lake Merritt to High Street, includes Districts 1, 2, 4, and 5



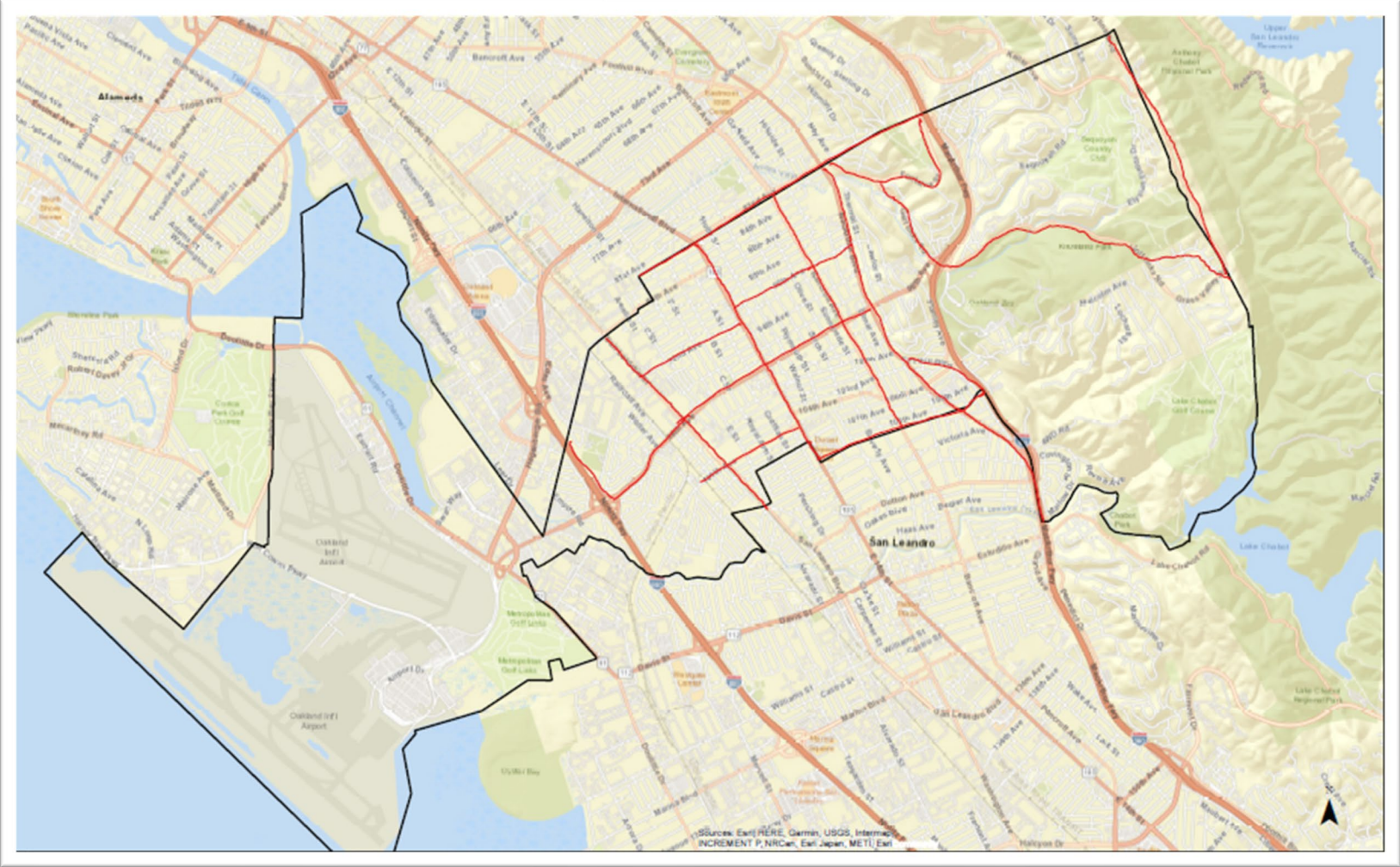


## Zone 3: High Street to 82nd Avenue, includes Districts 4, 6, and 7



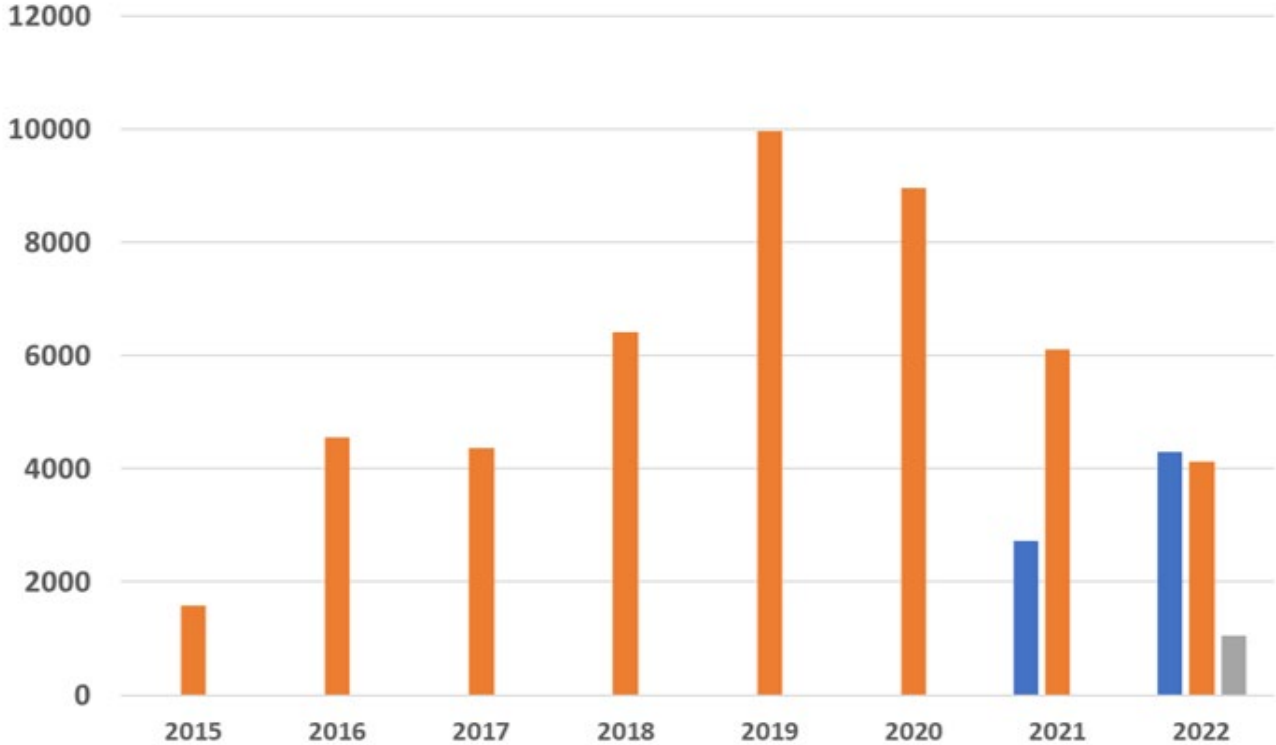


**Zone 4: 82nd Avenue to San Leandro Border, includes Districts 4, 6, and 7**

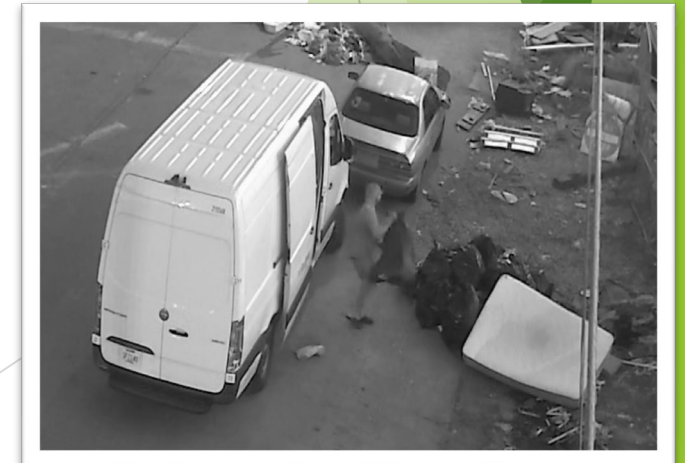

# Oakland Public Works - Illegal Dumping Report

## ENVIRONMENTAL ENFORCEMENT UNIT

- Charged with enforcing illegal dumping restrictions and regulations.
- Initiated in the early 2000's - Disbanded in 2011 - Restarted in March 2019
- Initially included staff of 4 Environmental Enforcement Officers (EEO)
- Now includes 10 budgeted positions:
  - 8 EEOs
  - 1 Administrative Analyst I
  - 1 Clean Community Supervisor
- Patrol 4 Zones of the city and monitor hotspots
- Monitor Illegal Dumping Surveillance Camera footage.
- Issue citations for violations of Oakland Municipal Code (OMC) Section 8.28.

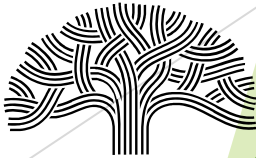
- The Environmental Enforcement Unit has issued more than 1,977 citations for illegal dumping since the program was relaunched in February 2019.
- 69 of those citations have been issued based on data from the Surveillance Camera Program that was launched 11 months ago in February 2022.

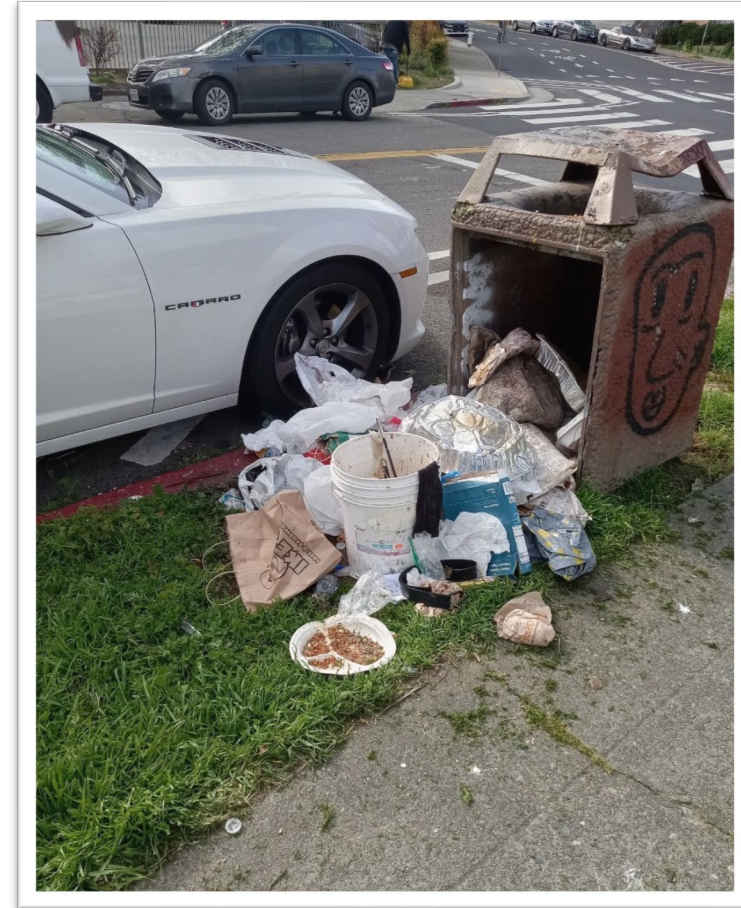

# Oakland Public Works - Illegal Dumping Report

## ENVIRONMENTAL ENFORCEMENT UNIT *continued*

- Utilize data provided by the City's solid waste management contractor, Waste Management of Alameda County (WMAC) and other methods, to ensure commercial businesses have the mandatory trash and recycling collection services.
- Monitor instances of unlawful dumping in or near litter containers used by commercial businesses.
- Can register businesses for trash service if they are found to not have it.

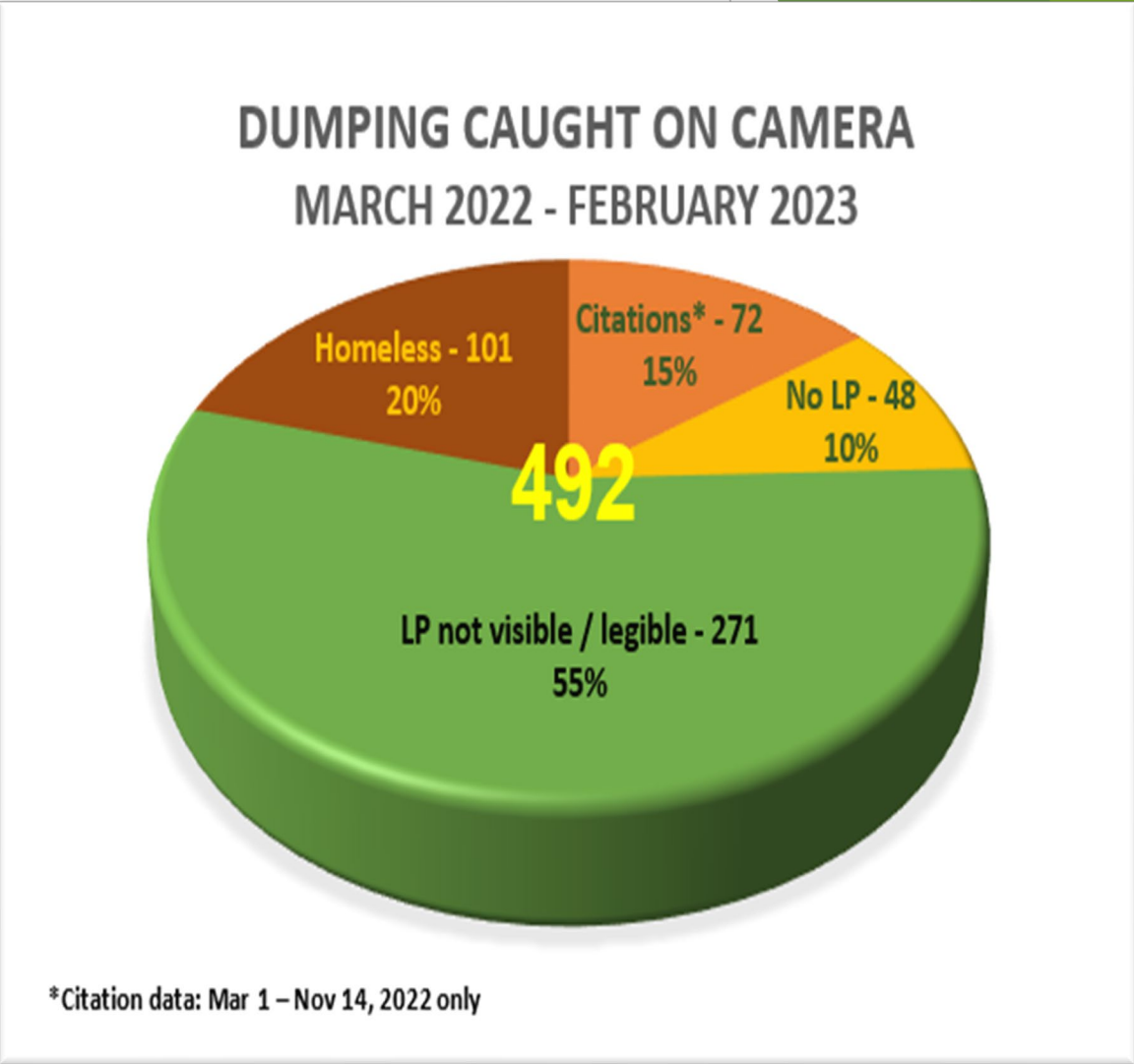

## Parks and Tree Services Division

- The Parks and Tree Services Division (PTSD) is responsible for **debris removal within City-owned parks, medians, and open spaces**, except for debris removal that is clearly associated with homeless encampments.
- Illegal dumping is removed from parks 7 days a week. More on weekends when the parks are used more heavily by the public.
- **Litter removal now represents 50% of labor hours**, which significantly reduces the time for landscaping and tending to park spaces.
- Parks staff have recently started tracking illegal dumping volumes separately from litter can volumes and will be able to report on these figures in next year's report.

## Stewardship Program (Environmental Services Division)

Leads community-oriented cleaning initiatives:

- Adopt-a-Spot
  - Adopt-a-Drain
  - Martin Luther King Jr. Day of Service in January,
  - Earth Day in April
  - Creek to Bay Day in September
  - Neighborhood Bulky Block Parties
- In 2022 **10,270 community members** contributed **60,426 hours of volunteer time** to cleaning the city, resulting in the removal of **2,765 cubic yards of litter and debris.**
  - Assisted by 3<sup>rd</sup> party programs:
    - **Lake Merritt Institute** – Cleaning and community engagement around Lake Merritt
    - **Team Oakland** – Youth engagement jobs program to clean and green

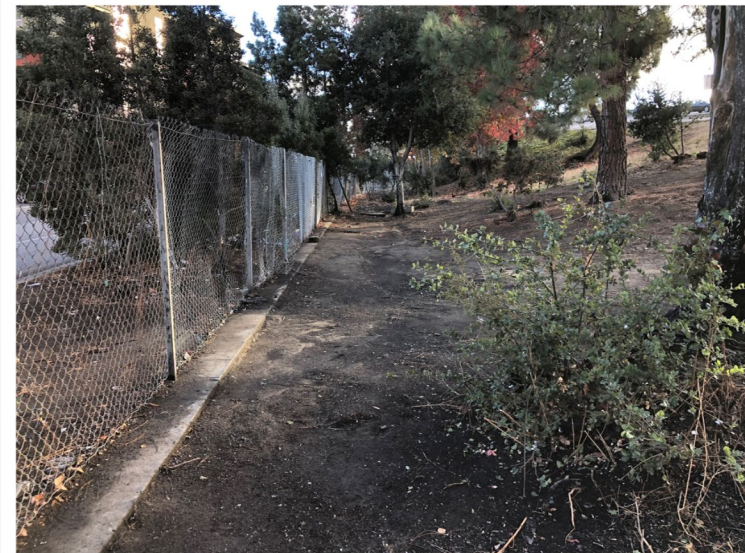

## Partnerships with Non-Profit Organizations

**The Beautification Council (BC)** – Works with unhoused residents, unemployed, and justice-system involved individuals to micro-clean and sanitize homeless encampments after the City removes the bulk of the debris. Under a grant from CalTrans, the City contracts with BC to remove litter and debris from the State's right of way.

**Downtown Streets Team (DST)** – Uses a volunteer work experience model where unhoused residents conduct litter and trash removal in exchange for case management, employment services and a basic needs stipend. Routes in four designated areas - East Lake Merritt, Saint Vincent de Paul, International Blvd, and Fruitvale - are maintained weekly by DST.



# Oakland Public Works - Illegal Dumping Report

## Enforcement Of Illegal Construction And Demolition Debris Haulers

- Unscrupulous and illegally operating haulers contribute to the City's illegal dumping problem.
- Enforcement of Construction and Demolition (C&D) debris hauling requirements - building permit holders who hire haulers to transport C&D debris without a City-issued non-exclusive franchise contract can receive Notice of Violation, penalties, and/or fees.
- Recently-adopted amendment to OMC Section 15.34 will increase the number of permitted construction projects that fall under C&D debris recycling and hauling requirements.

## BULKY DEBRIS SERVICES

### Curbside Bulky Pickup

- WMAC provides curbside bulky pickup service - scheduled by appointment - to residents of 1-4 unit single family dwellings (SFD) since 2005, and to residents of 5-plus unit multi-family dwellings (MFD) since July 2015.
- SFD may schedule two appointments per year. Average of 1,965 appointments per month.
- MFDs may schedule one appointment per year. Average of 472 appointments per month.

## BULKY DEBRIS SERVICES

### Neighborhood Bulky Block Parties

- Started in Fall 2022
- Brings the popular *Bulky Block Party* into some of Oakland's neighborhoods most affected by illegal dumping.
- Paired with other strategies and services to empower the community to be stewards and maintain cleaner neighborhoods such as:
  - Neighborhood canvassing to raise awareness of the event and other services
  - Hosting same-day volunteer clean-up supported by KOCB staff and services
  - Installation of illegal dumping camera at neighborhood dumping "hot spot"
  - Community appreciation and recognition event



# Oakland Public Works - Illegal Dumping Report

## Strategies for Improvement

### **Increasing Enforcement**

- On-board all EEU positions
- Explore Opportunities to Partner with Alameda County Sheriff or District Attorney's Office
- Publicize when dumpers caught
- Adding License Plate Reader cameras and satellite camera to improve images of dumpers and increase number of citations issued

**Ensuring Businesses Have Adequate Garbage Service** –There may be as many as 6,800 businesses that are not signed up for mandatory garbage service.

**Examine Opportunities for Upsizing Trash Containers** –Disproportionately high-cost large cans lead to contamination of recycling and green carts and dumping.
