

RESOLUTION NO. 91003 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR 1) TO ACCEPT A GIFT OF IN-KIND SERVICES PURSUANT TO THE AFFILIATION AGREEMENT WITH THE UNIVERSITY OF SAN FRANCISCO SCHOOL OF NURSING AND HEALTH PROFESSIONS TO IMPLEMENT NURSE-LED AND PUBLIC HEALTH INITIATIVES TO EXPAND HEALTH AND WELLNESS ACCESS, STUDENT ENGAGEMENT AND COMMUNITY PROGRAMMING FOR OLDER ADULTS AT AN ESTIMATED VALUE OF NOT TO EXCEED \$150,000 PER YEAR FOR UP TO THREE YEARS AND 2) TO NEGOTIATE AND EXECUTE ANY ADDITIONAL AGREEMENTS REQUIRED TO FACILITATE RECEIPT OF THE IN-KIND SERVICES

WHEREAS, on September 11, 2025, the City of Oakland Human Services Department (HSD) entered into an Affiliation Agreement with the University of San Francisco School of Nursing and Health Professions (USF SONHP) to collaborate on strategies to address the health, safety, and social connectedness of Oakland's growing older adult population; and

WHEREAS, the Addendum No. 1 to the Affiliation Agreement establishes the initial scope of work, student placement structure, and collaborative initiatives and projects to be implemented jointly by the City and the University; and

WHEREAS, this Addendum authorizes implementation of Nurse-Led and Public Health Initiatives, including:

- Health and Wellness Access & Prevention services;
- Digital Literacy and Connected Seniors programming;
- Social Connection and Safety initiatives;
- Workforce Development & Student Engagement activities; and
- Policy, Data, and Strategic Planning collaboration; and

WHEREAS, these initiatives align with the City's WHO Age-Friendly framework and will support Oakland's older adult residents, particularly historically underserved communities, by expanding community-based services, improving health and safety outcomes, and enhancing social connection; and

WHEREAS, USF SONHP will provide undergraduate and graduate students in nursing and public health for placement at City of Oakland Senior Centers and affiliated community sites, providing in-kind services valued at approximately \$104,500 annually at no direct cost to the City; and

WHEREAS, primary project sites include the Downtown Oakland Senior Center, North Oakland Senior Center, West Oakland Senior Center, and East Oakland Senior Center, with additional satellite and mobile wellness hubs across the city; and

WHEREAS, the initiatives will advance the City's strategic goals by increasing access to health promotion, prevention, and wellness services, strengthening workforce pathways, and supporting data-informed policy and advocacy efforts; and

WHEREAS, approval of this Addendum will enable formal implementation of these initiatives and student placements under the umbrella Affiliation Agreement; and

WHEREAS, this Addendum represents an in-kind contribution valued at approximately \$104,500 annually (and not to exceed \$150,000 annually), with no General Fund expenditure required by the City;

WHEREAS, this Addendum No. 1 authorizes student placements and program implementation at designated senior centers and community sites throughout Oakland for one year and future addendums will cover subsequent years for a total of up to three years; now, therefore, be it

RESOLVED: That the City Council hereby authorizes the City Administrator to accept a gift of in-kind services pursuant to the Affiliation Agreement between with the University of San Francisco to implement Nurse-Led and Public Health Initiatives to implement nurse-led and public health initiatives to expand health and wellness access, student engagement and community programming for older adults at an estimated value of not to exceed \$150,000 per year for up to three years; and be it

FURTHER RESOLVED: That the City Council hereby authorizes the City Administrator to negotiate and execute any additional agreements (addenda) required to facilitate receipt of the in-kind services

FURTHER RESOLVED: That the City Council hereby authorizes the City Administrator to take all actions necessary to implement this Addendum, including the execution of any necessary agreements, amendments, or modifications consistent with its intent and purpose.


