#### **SUMMARY**

The City Council's Annual Recess began August 1, 2006 and ended September 5, 2006. During the Annual Recess the Mayor was authorized to take such actions that would normally be taken by the City Council during the period of the Annual Recess except for duties reserved to the City Council by the City Charter, pursuant to Resolution No. 79006 C.M.S., dated January 4, 2005.

## KEY ISSUES AND IMPACTS

The City Council granted authorization to the Mayor to take action on procurement of certain supplies and services exceeding \$500,000 and certain professional services contracts exceeding \$150,000 during the 2006 Annual Recess, pursuant to Resolution No. 79006 C.M.S., dated January 4, 2005.


